- Providing as much detail as possible, when possible, so you can trust the board is being transparent about its decisions and you can trust we are acting in the community’s best interest.

What I ask of the community and myself:

- Be open to hearing questions, new information and concerns – please talk to me.
- Presenting shared thoughts and POVs into the discussion and decisions the board must make.
- Be respectful in disagreements and supportive in acknowledging any conflicting needs that arise and must be resolved. Sometimes we can’t always have what we want, but we can always try to make sure the needs of the many outweigh the needs of the few.

My last commitments as a candidate:

- I will not take any donations from any person or organization. My campaign budget will not exceed \$100 (I plan to buy a banner for visibility to be used at several neighborhood “picnics in the park”)
- I have no interests in any outcome of decisions that may come before the board – except the impact on my Property Tax bill on my personal residence.

## **ROBERT DOUGLAS MARSH**

Robert Douglas Marsh currently serves in his first year as a member of the Board of Directors of the Westerly Creek Metropolitan District. He seeks re-election to help lead the District's transition to ownership of community assets and all that entails.

A resident of Central Park for six years, his 25 years' experience as a public water authority board member is particularly relevant.

Marsh served as one of five members, *South Central Connecticut Regional Water Authority (RWA)* from 2010 to mid-2017. The utility provides water and land management services to nearly 500,000 in 20 cities and towns. The RWA regularly issued and refinanced sizable capital improvements bond issues and has a robust asset management program. Previously, he chaired the RWA's oversight body, akin to a regional public utilities commission, for 8 years.

During his career, Marsh also served as an officer or board member of a dozen nonprofits and professional societies.

Marsh led the boutique consulting firm Organization Dynamics LLC for 30 years, strengthening more than 300 community and economic development nonprofits across the nation by improving governance and operating practices and guiding strategic planning. The firm also provided executive search services. Marsh has undertaken similar international assignments on behalf of Ernst & Young, Deloitte, KPMG, USAID, and the U.S. State Department.

Before founding Organization Dynamics, Marsh served as CEO and in senior staff positions for metro and local chambers of commerce.

Marsh earned his B.S. with honors in Urban Planning and Regional Development from Ball State University. He is a graduate of the Institute for Organization Management and its three-year Academy program associated with the University of Notre Dame and the U. S. Chamber Foundation. He also was an Associate Fellow at Yale University.

He is retired and has no current or planned ties to developers, commercial interests, or financial institutions.

### **Why Should You Elect Robert Douglas Marsh**

A new era is upon us. Park Creek Metropolitan District will, in classic developer fashion, begin to convey "community assets" to Westerly Creek Metropolitan District (WCMD) at "build out" later this year or early next.

As a first-year WCMD board member I initiated a due diligence process to make certain that taxpayer and resident interests were well-served during this transition. The District has selected a consulting engineering firm familiar with metro districts to help. I seek re-election to see the process through.

Historically WCMD had one principal responsibility—fund Park Creek's budget, but without being permitted to provide input. In other words, WCMD was tasked with setting the special district tax rate and little else. At "build out", Westerly Creek begins to take ownership and becomes responsible for O&M (operations and management), not just funding.

For 25 years I served first on the regional oversight board of a water authority (akin to a public utilities commission) serving Greater New Haven, then on its operating board. This two-board structure has analogies to the PCMD/WCMD relationship. Significantly, like PCMD the utility was frequently in the bond market. Experience matters.

I am retired and independent, without commercial interests at stake. I have the time to devote to WCMD—and to this community—in what will be a demanding few years.
