Sometimes we have scheduling conflicts because Courts of Honor have been scheduled often on the same date and sometimes at the same time. 1. The name of the new Eagle Scout(s) as it will appear on his Eagle certificate. Middle initial?
2. The name and location (complete address) of where the Court of Honor will be held confirming both the date and time.
3. The Troop number, name, telephone number and e-mail address of a contact person for the new Eagle Scout, i.e. scoutmaster, parent, mentor, etc.

In addition to the congratulatory certificates we present, we can also present a USMC Ka-Bar knife to the new Eagle Scout. Due to both the number of presentations we make and the cost of the knife, the Detachment has requested that the Unit/Parents cover the \$65.00 cost of the knife. These particular knives sell retail for \$75.00 or more. Our Detachment has made arrangements with the Ka-Bar Corporation to purchase them at a reduced cost. This is a great part of the ceremony, but it is optional. Our Detachment is a non-for-profit organization and our revenue is limited to the donations we receive. The entire \$65.00 covers the cost of the Ka-Bar knife. Additional donations are welcomed, but are not necessary.
