Election Process:

Every Calendar Year, the California Welfare Fraud Investigator's Association will accept nominations for upcoming open board positions. Board positions are filled for three year terms and are offset to insure we have experienced board members in place at all times.

An electronic announcement was released in September this year requesting names of all those interested in running for pending vacant positions. Candidates listed below are those who have expressed interest and are running for those positions. Vacant positions this year include:

- Zone II
- Zone III
- Zone V
- Director at Large
- DHCS Director at Large

The Secretary for CWFIA along with the elections committee will send out an electronic ballot to all members. Members will be given 10 days to vote for their respective candidates. The votes are tallied electronically and reviewed by the elections committee. Once all votes are counted, a new board of directors will be announced and will begin serving the association on January 1, 2025.

I started my career with Los Angeles County as a Veteran Intern assisting Eligibility Workers in several program units such as; Medi-cal approved and intake for CalWORKS and CalFresh. After several months as a Veteran Intern, I was promoted to Eligibility Worker 1 were I served the public as an Intake worker for Cal Works. In 2019 I applied, tested, interviewed, and then promoted as a Welfare Fraud Investigator Trainee. I attended the Specialized Investigators Basic Academy at Golden West College where I graduated and was elected as Class President. As class president I was allowed the opportunity to lead a class of 32 investigators from various agencies and counties.
