- c. Position the camera directly above the ID to avoid angles and shadows.
- d. Ensure the entire ID is visible in the frame and focus until the text and photo are sharp.

### 3) Sending Your ID Photo

- a. Be ready to upload or email your photo when you submit your membership application. We support .jpg and .png files.

## Security and Privacy Assurance

- 1) **No Storage of ID Photos** Please be assured that your ID photo will not be stored. It is only used to verify your identity during the initial setup of your membership. Once verification is complete, the photo will be permanently deleted from our records.
- 2) **Confidential Handling** All documents and personal information provided are handled with the utmost confidentiality and in compliance with privacy laws and regulations.

# The Lavigne Show Membership Confidentiality Agreement

## 1) Introduction and Acknowledgment
