**RELEASE / AUTHORIZATION FORM**

I am participating/am allowing my child, \_\_\_\_\_, to participate in Forever Faithful 's camp with the understanding that I will not hold Forever Faithful , Whispering Oaks, Teri Matter, Verdell Matter, Jerry Matter and/or their family, employees or assigns, liable for any accident or injury to me/my child, or to any person accompanying me/my child, or to my/my child's horse, while on the premises of Forever Faithful or during activities held off premise (example: a trail ride in the National Forest which adjoins the premises of Forever Faithful ). Nor will I hold the above responsible for any loss of or damage to tack, clothing, equipment or any items left at Forever Faithful.

I understand and agree that Forever Faithful is a working ranch and that activities will be on and around horses. I realize that even under well supervised conditions there is still risk involved. Horseback riding is classified as rugged recreational sport or activity and that there are numerous obvious and non-obvious inherent risks always present. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from a horse to the ground it will generally be at a distance of from 3 1/2 to 5 1/2 feet, and the impact could result in injury/death to the rider. Forever Faithful chooses lesson horses for their calm dispositions and sound basic training, as is required for use as riding horses for novice and beginning riders. Although Forever Faithful follows a risk reduction program no horse is a completely safe horse. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: stopping short, changing directions or speed at will, shifting their weight, bucking, kicking, biting, or running away from danger.

**WARNING: Effective September 1, 1995, Texas State Law (Chapter 87, Civil Practice and Remedies Code) states that; "An equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities".**

**SWIMMING/LIFEGUARD NOTIFICATION:** I understand that participants may swim during scheduled times in the livestock pond at Forever Faithful. This activity will be supervised. **Life Vest MUST be worn. They are MANDATORY**
