## **Open Issues**

1. Review of the November General Meeting and November 2024 Board Minutes

Jordan Skinner made a motion to accept the November General Meeting and November Board Meeting minutes. Trudy Moody seconded the motion. None opposed and the motion passed.

- 2. January Show Date Change
  - a. Move from January 10-12 to February 7-9, 2025
- 3. Canton Facility Update
  - a. Melody will work with Alvin and Lisa on the contract for the facility
  - b. We will only use the outdoor ring and the covered ring and the office inside- we will not use the coliseum ring
  - c. Will have security but not for 24 hours every day of the show. We will work with the Sherif's Office
  - d. Waiting on final numbers before determined total cost
  - e. We will set dates with Alvin for follow up on checklist needs prior to the show
  - f. Covered ring will need some work on the footing before the show
  - g. Office will be set up on Thursday or possible late Wednesday- Jordan will bring the items from storage
  - h. Horses and set up will happen on Thursday
  - i. We will need a PA system (wired system only covers the indoor ring and barn area). May need one for each ring. Shannon to test her JBL speaker for range

### 4. February Show

- a. Jordan will check on the back numbers left to see if Mandy needs to order any additional numbers
- b. No Food Truck
- c. Soup Supper Saturday night during the Dad's Lead Line Class (Pops and Ponies)
  - 1. Barns are asked to bring 2 soups each and paper products
  - 2. Board Reps to contact barns for participation:

  - c. Mama Hamils will cater the dinner

  - d. Cupcakes for 75 people
  - e. Iron Horse will provide cash bar again
  - f. Linens provided by Great Southern Events
  - g. Photo Backdrop ordered from KPEP (will check on lighting)
  - h. Do we want a dedicated photographer? (MHJA could pay fee and offer an ad in the prize list- need to confirm no charge for individual pictures and no watermark)
  - i. Tickets (last year \$55 Early sales, \$60 week before and then \$65 at the door)
    - 1. \$50 Early sales
    - 2. \$55 one week before
    - 3. \$60 at the door
  - j. Silent Auction items to Melody and Jamie

### 8. MHJA Online Store

- a. \$50 fee to open the store
- b. Business will give us the items at cost and then we decide the % of markup
- c. Must determine at least 13 items for the store
- d. Only print what is ordered (screen printing)
- e. Set to open at the Banquet and run through the first show
- f. Once the store closes, the business orders the items and prints, ships to each person. Can take up to 4-6 weeks
- g. Nathalie needs to file of the MHJA logo
- h. Nathalie will get the cost for hats, sweatshirts and t-shirts
- 9. Board Member of the Year
  - a. For 2023-24 Board of Directors
  - b. Stephanie will work with Jamie on getting nominations and gift/award
  - c. Shannon will send Stephanie the list of 2023-24 Board for the link
- 10. List of Committee sent to the Board for considerations and discussion at next meeting
