Agent and on behalf of myself and my principals, I agree that I am subject to the Bylaws and Rules of MHJA and the rules of its competition. I agree to be bound by the Bylaws and Rules of the MHJA and this competition. I will accept as final the decision of the Healing Committee on any question arising under the Rules and agree to release and hold harmless the competition, the MHJA, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or to participate under the rules and every horse I am entering is eligible as entered. MHJA RELEASE, ASSUMPTION OR RISK, WAIVER, AND INDEMNIFICATION I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, lessee, owner, agent, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I AGREE to release the MHJA from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me and my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Association or the competition. I AGREE to expressly assume all risks of Harm to me and my horse, including Harm resulting from the negligence of the MHJA. I AGREE to indemnify (that is to pay any losses, costs, damages incurred by) the MHJA and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the competition. I have read the MHJA Rules about protective equipment and I understand that I am required to wear said protective equipment I acknowledge that the MHJA requires me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and I AGREE to assume all of the obligations of this Release on the child's behalf. I AGREE that "the Association" and this "competition" as used above includes all of the officials, officers, directors, employees, agents, personnel, volunteers. I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the MHJA on the official Injury.
