 I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the USEF rules about protective equipment, including GR801 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the USEF strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
