Open Issues

1. Review of the February 2024 Minutes

Jamie Floyd made a motion to accept the minutes. Brittany Strong seconded the motion. None opposed and the motion passed.

- 2. Treasurer Report
 - a. Banquet Breakdown
 - 1. Cost \$9,768 (not including tickets)
 - 2. Ticket Income \$7,865
 - 3. Silent Auction Income \$4,000
 - b. January Show Breakdown
 - 1. Expenses \$21,864
 - 2. Income \$19,802 (includes prize money given out but not sponsorship income)
 - c. Upcoming Financial Changes
 - 1. Decrease catering cost for staff meals by ordering individual meals and not bulk
 - 2. EMT change (decrease cost by 50%)
 - i. G. Pickle no longer certified for life saving measures in Rankin County- could cause liability for association
 - 3. Increase stall cost
 - 4. Possible increase to shavings cost
- 3. April General Meeting
 - a. At Leah Ivey's business in Gluckstadt

- 4. Bylaws Committee
 - a. All changes already approved in previous meetings except for possible changes in membership fees
 - b. Discussion for Changes in Membership Fees
 - 1. Review of other states
 - i. Alabama (\$38 individual, \$63 family, \$353 lifetime, \$78 barn)
 - ii. Middle TN (\$45 individual, \$350 individual life, \$60 family- limit of 2, \$500 family lifetime, \$10 horse, pony)
 - iii. LHJA (\$40 individual junior, \$40 senior individual, \$50 farm)
 - iv. WTHJA (\$200 lifetime, \$50 yearly)
 - 2. Possibly removing Lifetime membership option, grandfathering all existing lifetime members. Would create steady income for the association
 - 3. Only 22 memberships this year, 6 were lifetime memberships
 - 4. Need to increase the number of memberships sold per year to create a steady stream of income

Mandy Dearman made a motion to increase the coast of individual membership to \$40, increase family membership to \$65 and remove the lifetime membership option. Salina Kelly seconded the motion. None opposed and the motion passed.

- 5. Show Committee
 - a. Possible December Show in Canton for 2024-25 Show Year, Fontaine to contact Canton
 - b. Need help from Board Members for jump storage and transportation on Wed before the show
 - c. Need Show Committee meeting before the July Show (maybe after Easter)
 - d. Horse Medal Trophy- true finals should be held at the 1st show of each year, inviting back the to 6 riders to compete for the trophy. No ribbons just the trophy to be awarded at the Annual MHJA Banquet
- 6. Creation of a Master Calendar to track shows and avoid conflicts
- 7. Prize Committee
 - a. Inventory completed on ribbons and prizes
- 8. Points and Affiliation Committee
 - a. Request to send points totals out after each MHJA Show
 - b. Aim to release every 3 months to eliminate long term look back
 - c. Points will be final after comment period at each release
 - d. Excel shows have been in touch about affiliation, Salina to follow up this week
- 9. Ads and Sponsorships
 - a. Still missing 8 payments
 - b. Melody to coordinate with Stephanie to collect
 - c. Follow up with Pig & Pint on ad for prize list
