



FOSTER TO ADOPT CONTRACT FOR COFFEE CAUSE FOR PAWS, INC

Coffee Cause for Paws, Inc. (hereafter "CCFP") is entering into this Foster-to-Adopt Agreement as a Courtesy to me to allow me to have custody of this animal before it can be spayed or neutered or complete heartworm treatment. The animal shall remain the sole property of CCFP until it is spayed or neutered or heartworm negative and the adoption is finalized. If for any reason the adoption is not finalized, I understand that upon the request of CCFP the animal shall be relinquished to CCFP. *

I agree to pay the balance of the adoption fee upon completion of this Agreement.

I will provide the animal with good care, including but not limited to proper food, fresh water, shelter, exercise, grooming, training and medication when required. I will comply with all instructions received from CCFP and will not deviate from any instructions as to the care and maintenance of the animal without consulting with a representative of CCFP.

I have been advised that CCFP uses pediatric spay/neuter for young foster animals as soon as it is appropriate as advised by veterinarians used by CCFP. CCFP will make arrangements for spay/neuter surgery and I agree that I will take this animal(s) to its spay/neuter appointment and for any other necessary veterinary care as directed by CCFP unless other arrangements have been made by mutual agreement. There are no exceptions to the requirement that the animal must be spayed/neutered before its adoption is complete.

I understand veterinary costs for routine flea, parasite control, illnesses, or accidental injuries sustained by the animal after it came into my care will be my responsibility unless otherwise indicated by CCFP.

I understand that other animals in my household could be exposed to medical or behavioral conditions that have not been recognized in the CCFP foster-to-adopt animal. CCFP is not liable for any disease or injury to my companion animals or other exposed animals.
I agree not to hold CCFP responsible for any damages to persons or property incurred by the animal. I specifically relieve CCFP of any responsibility pertaining to any damage to property or personal injury or any occurrence relating to the animal and shall hold CCFP harmless regarding any damage or injury(ies) of any nature whatsoever, and agree to notify CCFP immediately of any damages and/or injury(ies).
