## **FOSTER PARENT AGREEMENT**

**The Foster Parent must own their home or have permission from their landlord to have a foster pet!!**

**The Foster Parent agrees to the following:**

**1. Duty not to sell:**

The foster parent agrees that the Pet is in "FOSTER" and will not be sold, adopted, or given to any other party until adopted according to CCFP protocols.

**2. Appointments:**

The Foster Parent shall be responsible in maintaining the pet's health including medicines, treatments, and vet appointments paid by CCFP. All vetting must be done through agreed upon vet clinics and the foster will be responsible to make the animal available for transport and or transport themselves to and from all appointments.

### **3. Pet Care**

Foster parent agrees to take care of the animal with humane and responsible manner.

### **4. Foster Period:**

The Foster parent agrees to foster the animal in their home for the period of time required for the animal to be adopted, according to the protocols of CCFP.

If a foster is unable to fulfill this obligation, a minimum of 72 hours' notice is required and the foster will continue to foster until another foster can be found to transfer fostership.

### **5. Responsibility to Present Pet:**

It shall be the responsibility of the foster parent to have the pet appear at adoption events. In the case that the foster is unable to attend the event, it is the responsibility of the foster to arrange for another foster parent to transport the pet to the event unless the Dog Coordinator/foster parent decides the pet is not ready.

### **6. Supervision:**

It shall be the responsibility of the foster parent to ensure that the pet is well supervised during any outdoor activities. This includes any activities with strangers, other pets, or children. The pet must be on a leash with proper ID tags attached at all times. It is the responsibility of the foster to maintain the safety and security of the pet while in care.

### **7. Name of Pet:**

Foster parent agrees that the name of the pet that is given to them by CCFP is the only name and shall be maintained at all times. The foster may not at any time change or rename the pet.

## **8. Food and Water:**

Foster Parent agrees that it is their responsibility to provide fresh food and water daily to the pet. The food must also be approved by CCFP. Should they need help with obtaining the approved food for the pet that the foster parent will notify CCFP immediately for help.

## **9. Escaped or missing pet:**

In the case the pet should manage to escape or become lost, it is the responsibility of the foster parent to notify CCFP immediately to help coordinate a search and rescue of the pet. The pet should always be on a leash with proper CCFP tags attached at all times.

## **10. Pet Medical Care:**

It shall be the responsibility of the foster parent to notify CCFP immediately should there be any medical emergency of the pet. Pictures and adequate descriptions are required and the foster parent should provide any first aid necessary to ensure life for the pet.

## **11. Custody of the Pet:**

It is the responsibility of the foster to maintain custody of the pet at all times. This includes allowing the pet to go to family, neighbors, or friends. Only those fosters approved by CCFP are allowed to have custody of the pet. If the foster has to be out of town, it is the responsibility of the foster to arrange for "babysitting" with another CCFP foster or boarding facility approved by the Foster Coordinator. I further agree not to take the pet out of the state of Georgia without express consent of the Foster Coordinator.

## **12. Pet is a Companion:**

The foster agrees that the pet is a companion and will share the foster's home. Foster pets are not allowed to stay

outside for any length of time without the supervision of the foster. Only approved outdoor kennels are allowed. This must be approved by CCFP prior to any foster pet being housed in a kennel.

### **13. Foster Parent Personal updates:**

It shall be the responsibility of the foster parent to notify CCFP of any changes of address, phone, and email information. CCFP reserves the right to observe physical property where any foster pet is cared for.

### **14. Relinquishment of foster responsibilities:**

It shall be the responsibility of the foster parent to notify CCFP should the foster no longer be able to fulfill this obligation. A 2-week notice is required to allow for the pet to safely be transferred to another foster. If the foster parent is found to be unfit for any reason, CCFP will recover custody of the pet from the foster and the foster will no longer be allowed to foster for CCFP.
