### Anderson Area Crime Stoppers

On July 19, 2024, we received a tip stating that Marlie Harrison and her mother, Angela Harrison, were dealing meth and fentanyl from their residence. The tip was forwarded to the Narcotics Investigations Unit where they conducted their investigation.

On July 30, 2024, NIU executed a search warrant on the Harrison residence where more than 100 grams of methamphetamine was seized. There was also a stolen gun that was recovered. Both subjects were arrested and charged with trafficking methamphetamine.

**\*\*Mother and Daughter Arrested for Drug Trafficking Charges\*\***

The Narcotics Investigations Unit caught a mother with meth, standing in her in own driveway. Deputies went into Angelina Harrison's home along Whitehall Road with a search warrant, uncovering 18 grams of meth inside her bedroom.

Down the hallway, her daughter was hiding more drugs, including more than 55 grams of Meth, allowing detectives to charge Marlie Harrison as well.

Detectives collected more than 100 grams of meth and a stolen gun from inside their house and both mother and daughter are facing Trafficking charges.

### Crime Stoppers of Beaufort County

On 7/13/2023, the Beaufort County Sheriff's Office was dispatched to a hotel in Bluffton, SC for a report of Stolen Property. Upon deputy arrival, they met the victim who is employed at this location. The victim was able to provide security surveillance video, showing the victim set her bag down on a bench next to the front desk and then walk behind it. The video then shows the subject sit down on a bench next to the victim's Coach purse, a moment later pick up the bag and walk out of the hotel main entrance. Responding deputies were able to identify the subject from the video and subsequently an arrest warrant for Petit Larceny was obtained.

On 10/23/2024, a tip was submitted advising of a suspect selling Fentanyl pressed pills, fake Xanax and Methadone. The tipster advised the suspect was operating out of a local hotel room in Bluffton, SC. The tip information was delivered to Beaufort County Violent Crime Task Force who determined the suspect had active arrest warrants pertaining to the July 2023 incident and two additional arrest warrants out of Jasper County for Grand Larceny and Breaking & Entering Automobiles.

On 11/4/2024, the suspect was seen leaving a local hotel and traveling to a nearby restaurant. After observing the subject for about 40 minutes, he exited the restaurant. Deputies arrested the suspect without incident. Upon his arrest, the suspect was found to be in possession of a weapon on his person. The weapon was a 9mm Ruger firearm (\$400 value) that was found to be stolen out of Hinesville, GA.

At the time this tip was originally submitted, Crime Stoppers of Beaufort County had only been in operation for less than 1 month. If it had not been for the tip information, deputies would not have looked for the suspect in the area surrounding the hotel.

### Crime Stoppers of Greenville

In August 2024, a tipster provided Crime Stoppers of Greenville information regarding a suspected drug operation. The tipster gave a specific subject name and residential address for the storage of the drugs. California was referenced as a potential supply source and details were provided regarding the potential dangers of weapons being located. This information was assigned to the Greenville County Multi-Jurisdictional Drug Enforcement Unit (DEU).

In order to conduct a trash-pull for the residence, investigators and analysts linked this information with other known data pertaining to the referenced subject such as knowledge of minor children living at the address. The evidence from the trash-pull was found to be associated with a marijuana grow room or chamber. A search warrant was then obtained. Upon execution, a marijuana grow chamber was located in the basement area of the residence.

This investigation led to one (1) male subject being arrested for Possession with Intent to Distribute (PWID) Marijuana. Along with the several pounds of marijuana, firearms, magazines, and ammunition were also seized. The total value of all the seized drugs and contraband was approximately \$15,000.00.

With marijuana still being illegal in SC, this arrest helped to protect the public health and safety of the Greenville County community.

### **Crime Stoppers Success Story: Anonymous Tip Leads to the Arrest of Absconded Sex Offender**

The Laurens County Crime Stoppers Board is proud to announce another victory in the fight to keep our community safe, thanks to an anonymous tip from a concerned citizen.

On January 16, 2024, a tip was received through the Crime Stoppers website regarding the whereabouts of Derrick Lee Evans, a convicted sex offender who had absconded from his registered address months prior. Despite extensive investigative efforts, Evans had managed to elude law enforcement, raising significant concerns about community safety.

The anonymous tipster provided detailed information, including the location of a residence where Evans was reportedly staying. Acting swiftly, deputies in our warrants division located and apprehended Evans without incident. His apprehension not only ensures his accountability but also reinforces the message that Laurens County will not tolerate individuals who threaten the safety of our community.

Chairman John Young expressed his gratitude to the anonymous tipster- "This arrest highlights the critical role that Crime Stoppers and vigilant citizens play in our mission to protect the public. It's a perfect example of how working together can yield powerful results."

The anonymous tipster's identity remains confidential, as guaranteed by the Crime Stoppers program. An undisclosed cash reward was given to the individual for their assistance.

### Midlands Crimestoppers

On Wednesday, April 10, 2024 four juveniles robbed another juvenile at approximately 7 p.m. near a Food Lion on Decker Boulevard. The next day, April 11th, a fight broke out at a home on Angel Garden Way. That fight involved the robbery victim, their father and a group of other people.

During the fight, a 14-year-old Subject shot both the robbery victim's father, 36-year-old Marvin D. Archie, and shot 16-year-old Jayden Scales-Amiker. Archie and Scales-Amiker died following the shooting.

Investigating Deputies believed the 14-year-old Subject was armed with a pistol that had been illegally modified with a switch so that it was fully automatic.

Local Law Enforcement received a tip via Crime Stoppers that described all the teens involved, the vehicle used by some of the Subjects, and other details pertinent to the crime. While keeping the identity of the Tipster anonymous, Richland County Sheriff's Dept. investigated the provided information. As a result, the 14-year-old was arrested and charged with two counts of murder. Additionally, three more Subjects — Darryl Hamilton, Nadia Hamilton and Amir Fairwell — face charges related to both the robbery and the shooting incident that followed.

## 2024 Crime Stoppers Success Stories in South Carolina

In the early morning hours of March 17, 2024, there was a fatal shooting at a popular nightclub in Columbia, SC. The Richland County Sheriff's Dept. was called and responded, however the altercation had already concluded when Deputies arrived. It was reported that three individuals involved in the altercation had departed for the hospital before law enforcement arrived.

One of the wounded, a 24-year-old woman who sustained a gunshot wound to the upper body, tragically died. Additionally, two men were also injured, with one sustaining a gunshot wound to the upper body and the other to the lower body. Both men are received medical treatment at the hospital.

After the story was published by the local media, Law Enforcement received a Crime Stoppers tip that identified the persons involved, and gave a location.

Richland County Sheriffs were able to arrest Marcus Marshall and Cornelius Williams within 48 hours of the criminal act, and charge them in connection to the shooting. A third Subject involved in the incident, Khmari Renard Livingston, turned himself over to Law Enforcement in early April 2024.

### Crime Stoppers of Oconee County

4/16/2024: Received a tip on location of a wanted suspect - suspect ran to another building on the property - individuals in the location allowed law enforcement to enter and look for suspect at this time they located suspect and also arrested the person in the building for possession of narcotics.

8/3/2024: A post was done on our Facebook page to help identify a suspect in a burglary in a neighboring community - suspect was identified from the post and arrest warrants were issued - press release was done announcing that law enforcement was looking for the suspect that the tipster identified from the post - a call came in to local law enforcement from a mini warehouse storage unit stating they recognized the suspect and had recently rented a unit to her - upon searching the building over \$10,000 of stolen merchandise was recovered. Many items had not even been reported as stolen yet as they were stolen from student housing and students had not returned from summer break to realize their items had been stolen.

- Started Wanted Wednesday posts on Facebook - we have featured 20 individuals on Wanted Wednesday and 9 of the suspects have been arrested either due to tips to Crime Stoppers, calls to dispatch or turning themselves in.
- Created a new program called "Crime Stopper Community" to replace "Neighborhood Watch" program in our county. We have created signage for this and we work with area law enforcement to share this program.

#### WCSO Makes Arrest in Shooting Incident

**Subject:** Damien Kendrell Major, age 23, of Lane, South Carolina, was arrested and charged by Williamsburg County Sheriff's Office with Attempted Murder (S.C. 16-03-0029) and Possession of a Weapon During a Violent Crime (S.C. 16-23-0490(A)).

**Subject:** Trenton Ky'Veon Brown, age 17, of Andrews, South Carolina, was arrested and charged by Williamsburg County Sheriff's Office with Attempted Murder (S.C. 16-03-0029) and Possession of a Weapon During a Violent Crime (S.C. 16-23-0490(A))

On October 14, 2024, deputies from the Williamsburg County Sheriff's Office were dispatched to the intersection of Promised Land Road and Demascus Road in the Kingstree area of Williamsburg County in response to a reported shooting. Upon their arrival, the deputies discovered a victim suffering from a gunshot wound. The victim was subsequently transported by Williamsburg County Emergency Services (EMS) to a medical facility for further treatment.

The investigation into the incident has revealed that the victims were in the process of assessing their disabled vehicle when gunshots were fired. As a consequence, one of the victims was injured, and a nearby residence also sustained damage from the gunfire.

On November 1, 2024, Damien Kendrell Major was taken into custody by Williamsburg County Sheriff's Office for his respective charges.

On January 7, 2025, Trenton Ky'Veon Brown was arrested and transported to Williamsburg County Detention Center for his respective charges.

The suspect was arrested.

On January 11, 2024 deputies were able to make an arrest on a female by the last name of Montgomery who was a fugitive who had several warrants in Union County and another state. The tipster was able to help deputies by providing several alias Montgomery was going by. The tipster also provided information about several structures on the property that Montgomery was known to stay in. Due to the tip deputies were able to locate Montgomery hiding on the property and serve four general session bench warrants and a family court warrant on the subject. Deputies were also able to charge another subject on the property with resisting arrest and gather some drug information. Thanks to the crime stoppers tip several cases were cleared!

### York County Crime Stoppers

A tip was received in June of 2024 stating that there was an individual with active warrants in Fort Mill South Carolina. Investigators reviewed the tip and confirmed that the individual was wanted out of Wisconsin for a Felony Failure to Appear warrant with Nationwide Extradition. Officers were able to take the individual into Custody without incident and assist in getting them back to Wisconsin to face the outstanding charges.
