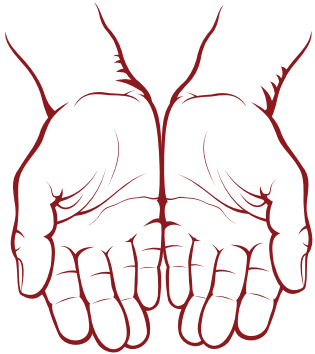


## Our Mission Statement
