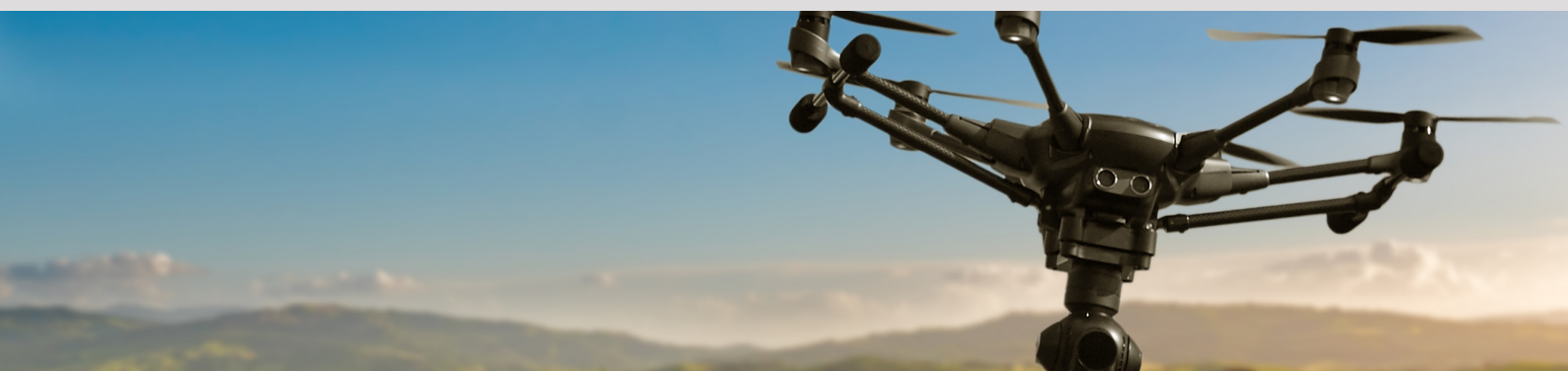
Benefits of Drone Surveillance:
