

Required Documents Checklist

ALL TRAVELERS must include the following documents in your package to G3:

- ☐ Your original valid signed passport. It must have two blank visa facing pages each other and more than six months before expiry
- ☐ Non-US citizens must provide a copy of their Alien Registration Card (A.R.C.) or I-95. Visa and original I-94.
- ☐ One completed and signed visa application form (see attached).
- ☐ One passport length (1" x 1") photograph (taken within the last 6 months, on photo paper and with a plain white background).
- ☐ Copy of flight itinerary

BURMESE AND FLIGHT CREW TRAVELERS must also include:

- ☐ A business letter from their U.S. company. This letter must explain the purpose of the trip and provide a financial guarantee. It must be on letter head and signed by a representative of the company other than the applicant. A sample is attached.

NOTES

Cambodian visas can be processed no more than 60 days before the date of entry to Cambodia.

For visa requests requiring 4C Home processing, G3 must receive all paperwork no later than 8:30 AM. Please send documents via FedEx or UPS with no signature required.

Send all required documents and the completed Traveler Information form to G3 using a service with tracking such as FedEx or UPS.
