RENTAL UPDATE

As a reminder, the Lafayette Place Governing Documents stipulate a 10% rental cap (20 units). No unit may be rented without prior approval from the Board of Directors. A copy of the Rental and Leasing Rules is attached.

Currently, there are 16 units rented, and 4 unit owners have been notified that they may advertise their unit for lease. Those owners have 45 days from the date of notification to submit a lease with a minimum term of 1 year. There are 12 additional units on the waiting list.
