Identify the PHA’s quantifiable goals and objectives that will enable the PHA to serve the needs of low- income, very low- income, and extremely low- income families for the next five years.</p> <ol style="list-style-type: none"> 1) WE HAVE HIRED A THIRD MAINTENANCE MECHANIC ASSISTANT IN AN EFFORT TO TURN UNITS AROUND QUICKER AND ADDED A NEW TRANSLATOR/INTERPRETER TO BETTER SERVE AND ASSIST AS WELL AS MEET THE NEEDS OF OUR HISPANIC POPULATION. 2) WE HAVE CHANGED THE PROCEDURES OF OUR DAILY OPERATIONS OF SCHEDULING ALL APPOINTMENTS FOR NEW APPLICANTS AND RESIDENTS ALIKE FOR SAFETY MEASURES TO PREVENT CONTRACTING THE CORONAVIRUS DURING THIS PANDEMIC (MARCH 2020 – CURRENT). WE WILL CONTINUE TO USE THE SAFE GUARDS AND EQUIPMENT PUT IN PLACE TO PROTECT AGAINST THE VIRUS. 3) WE WILL CONTINUE TO KEEP OUR VACANCIES TO A MINIMUM AS WE HAVE DISTRIBUTED THE WORKLOAD AMONG THE OFFICE AND MAINTENANCE STAFF ALIKE. 4) WE ARE INSTALLING NEW WINDOWS IN 49-1. THIS SHOULD LOWER THE UTILITIES BILLS/RATES FOR THE RESIDENTS AS WELL AS PROVIDE A SAFER AND MORE SECURE FEELING IN THEIR HOMES. THIS SHOULD ALSO CUT SOME OF THE EXPENSES INCURRED BY THE HOUSING AUTHORITY BY SAVING ENERGY. 5) WE WILL CONTINUE TO DEMOLISH OLD CRACKED AND BROKEN SIDEWALKS AND DRIVEWAYS AND INSTALL NEW DRIVEWAYS AND SIDEWALKS TO PREVENT TRIP AND FALL HAZARDS AT ALL SITES. 6) WE WILL CONTINUE TO SEEK EDUCATIONAL OPPORTUNITIES AND TRAININGS FOR ALL STAFF OF THE HOUSING AUTHORITY PERTAINING TO THEIR JOBS AND PERFORMANCE. 7) TO CONTINUE TO PUT PREVENTIVE MEASURES IN PLACE AND STAY HEALTHY.

Our policies and procedures are in place to ensure the safety of our residents as well as the employees. We continue to place those that have violated our lease agreement and rules of the Housing Authority on the No Trespass list. We have extra patrol by the Versailles Police Department and an office living in one of the unit where the crime rate and assaults were high. By having the officer on property, the number of domestic and criminal activity has declined by 70%.</p>
