#### **MINUTES FROM PREVIOUS MEETING:**

## CSM MANAGEMENT UPDATE FROM VP HOLLAND:

• First half 2024 assessments have been sent to homeowners.

#### FINANCIAL REPORT:

The financial report ending December 31, 2023, was presented by Treasurer Smiley.

- As of December 31, 2023, there is \$22,915.36 in the Association checking account. \$5,229.75 of this balance is for 2024 assessments paid in advance. The checking account balance on February 4, 2024, is \$30,070.48.
- There is \$962.50 of Prepaids as of December 30, 2023.
- There is one homeowner who owes part of their 2<sup>nd</sup> half 2023 assessments as of December 31, 2023 (Late Fee). The remaining homeowners have paid 2023 assessments in full.
- There is \$22.75 (Late Fee) in Accounts Receivable as of December 31, 2023.

The following is a Summary of Assessments as of February 5, 2024:

- There are six homeowners who have paid part of their 2024 assessments in advance in the amount of \$2,504.75 as of November 7, 2023.
- There are 29 homeowners who have paid all, and three who have paid part, of their first half 2024 assessments.

- There is \$4,528.00 (including late fees) in Accounts Receivable for the first half of 2024.
- There are 8 homeowners who have paid all, and 4 who have paid part, of their second half 2024 assessments.
- There is \$18,945.50 in Accounts Receivable for 2024.
- There is one homeowner who has paid the estimated 2025 assessment of \$630.00.

President Acres accepted the financial report as delivered.
