(With 94 homes, *The Gardens* is very similar to our neighborhood. It has no pool, no clubhouse, and few common areas. Just as we do, The Gardens also has to maintain its own streets and entry gates. Please note -

The annual dues cost at *The Gardens* exceeds HPT by \$2,140.  $(4 \times \$660 - \$500 = \$2,140)$
