Introduction by Rabbi Norbert Weinberg to the programs for absorption of Jews from the former Soviet Union

The Jews of the former Soviet Union (Russia, Ukraine, Moldova, Belarus, Georgia and Central Asia) since the Communist Revolution of 1918, experienced particular hardships from several ends:

- 1) A historic resentment of Jews in higher positions, dating back to Tsarist times
- 2) A political policy eliminating religion from both the public and private sphere, enforced, in some cases by fellow Jews, the Yevsektsia.
- 3) A policy to disconnect Jews from their fellow Jews worldwide, in particular in regards to Zionism and Israel, and concomitant, the gradual elimination of Jewish ethnic identity, again, a continuation of older Russian Tsarist policies.

As a result, Jews of the pre- WW II Soviet territories, over the course of 70 years, were distanced from contact with Jewry outside, Jewish observance was repressed, resulting in a disconnect between the Jew qua Judaism and the Jew as Soviet citizen. The same happened, but to a lesser degree, to the Jews of the territories absorbed into the Soviet Union after WWII, such as western Ukraine. For a description of Jewish life in the Soviet Union, see the book by Elie Wiesel, Jews of Silence.

Starting in the late 1960's, pressure built up, both by Jews inside the Soviet Union, and by Jews outside, to allow Jews to leave. (Two well known public figures in Los Angeles began their careers in fighting for the rights of Jews in the Soviet Union to leave, former Councilmember of LA City and Supervisor, LA County, Zev Yaroslavsky, and political figure Dennis Prager). There was a small movement of Jews out, under great difficulty, over the decades leading up to the fall of the Iron Curtain. With that "Tear the Wall Down" moment, the great majority of Jews finally were able to leave, seeking better opportunities. Many came to the USA, and Los Angeles became a favorite destination, with West Hollywood and the area around Hollywood Temple Beth El, becoming a significant hub.

Hollywood Temple Beth El became one of the hubs of service for these newcomers, and

one of the key elements was to help them absorb life in this "Brave New World" in which one could be free to be a Jew and live as a Jew, without questions asked. Through the portals of the synagogue came former Party officials, former Soviet missile and submarine experts, former Soviet journalists, and former popular Soviet entertainers and movie stars!

These are from my personal records regarding the services Hollywood Temple Beth El provided to the newly arrived refugees from the former Soviet Union. This reflects activities in 1993. The Jewish Federation of Los Angeles allocated a total of \$15,000 spread over two years.

A. Introduction: Hollywood Temple Beth El is the oldest Conservative congregation in the Hollywood/West Hollywood area. It provides the full range of normal congregational services to its members (i.e., services, programs, religious school, nursery school). Because of its facilities, it also houses the Herzl School, the only communal Jewish private High School in LA, the Creative Arts Temple, the Musical Dramatic Club, Senior Elites, the

American Congress of Polish Jews and Survivors of Concentration Camps, and a senior citizens kosher food program. Its public run the breadth of all ages, all social and economic levels, and Jews from a variety of origins (Holocaust survivors, Iranians, Israelis, North African, Russian, as well as veteran Americans). The synagogue has provided leadership in various Jewish causes, such as the University of Judaism, Jewish National Fund and Israel Bonds, and the pulpit has given constant support to UJA and Operation Exodus.

B. The Program- Hollywood Temple Beth El, a center for experimental programs for acculturation of 60,000 Russian Jews in LA, plans to hire a Russian -speaking program coordinator, with appropriate funds for programming and supplies, to coordinate the ongoing activities and to attract this large population to affiliation with synagogue life and involvement.

C.Problem- The turn of events in the former Soviet Union, as is obvious, has resulted in a massive exodus of Jews, many of whom will find their way to Los Angeles and the West Hollywood area in particular. The Los Angeles Jewish community needs to make every effort to absorb both the veteran and the new immigrants who are a potential source of new leadership for the Jewish community. Synagogues, historically, have been the locus of Jewish life; this historical fact must be translated into methods and programs which can speak to Jews who have been estranged, by events, from their heritage.

West Hollywood and the adjacent Fairfax area in Los Angeles is described as Moscow on the Pacific and Hollywood Temple Bet El is the only Conservative congregation located in the heart of that community. Approximately 60,000 Jews of Soviet origin have settled here in the past two decades and many more are expected to come.

Chabad has successfully capitalized on the services of a Russian-born Rabbi and have successfully raised \$700,000 from prominent Russian Jews in the community (none of them Orthodox) to open a center, which drew over 1500 people to High Holiday services on opening day of Rosh Hashanah(with tremendous local media coverage). This is ironic because the bulk of Russian Jews are secular, and Chabad ,it has been claimed, seeks to isolate them from the rest of the Jewish community.

The neighboring Reform synagogue has authorized its assistant Rabbi to handle all

Russian Jews, and has succeeded in augmenting its membership. Furthermore, Young Israel of Melrose has obtained a grant for a coordinator of activities to the Russian public.

Hollywood Temple Beth El alone in this area has not been in a position, till now, to attract this public, for a variety of reasons. We are concerned that this new wave of Jewish immigrants may slip through our fingers, the vast majority assimilating away from Jewish identity altogether, a minority gravitating to Chabad.

This is ironic because this synagogue, over a decade ago, held special High Holy Day services for new immigrants, and housed ,for a while, the offices of a Russian community organization. Because of our attractive sanctuary ,catering facility, and convenient location, many Russian Jews chose to hold their weddings here. This was the cite of the 10th Anniversary celebration of Panorama, the largest Russian-language newspaper in the country, and we have been working with the Association of Soviet Jewish Emigres.

D.Program Objectives- Our objective is very simple:

To consolidate our on-going work, and create further programming, which will draw the newly arrived immigrants to affiliation and involvement in synagogue life and send their children to Jewish schooling, and will involve the veteran Russian Jews, who have acculturated to America, to see their rightful place within the synagogue.

The objectives are measurable by an increase in enrollment of children in religious school, membership growth, and participation by Jews of Russian origin in voluntary and leadership capacities. These results should be noticeable within three years.

E. Methods-- With a new Rabbi and administration, the congregation has begun to make significant outreach once again to this public. Last year, thanks to a grant from the Bureau of Jewish Education we conducted a short- course Bar Mitzvah program for 10 new immigrants, for which we received good local publicity. We have held various events in which Russian immigrants were hosted here for Channukah and Pesah workshop, Shabbat

dinner, Shavuot lel Tikun.

This year, we have continued the Bar Mitzvah program, with 12 students, we are hosting a Sunday school program for 25 children and an adult education class, thanks to the Bureau of Jewish Education. We involve these children in our on-going activities, and the children and parents together share with the rest of our parents of the religious school, who themselves are to a great part not-so=new immigrants as well(Iranian, or Israeli). We offer them membership at a token rate, and, when the children will finish the experimental program, we hope to incorporate them into our regular Hebrew School program. In the planning as well, is a course in English for success, to help new immigrants break into a tight job market, as well as a Russian cultural center, in conjunction with a local organization, the Association of Soviet Jewish Emigres.

We even had started a Russian-counselling program under the auspices of the University of Judaism-Wagner program, which we had to cancel because we could not meet our own expenses and had to find a paying tenant for the office spaces we had allocated.

Our costs, in terms of under-writing these activities, and in terms of offering our services(high holidays and courtesy memberships) is very large. At the same time, as a result of past administrative difficulties of the congregation, we have no funds for any of these activities.

We therefore seek a Russian -speaking program coordinator to take care of all the on-going activities which we have initiated here, to reach out to the local Russian community, and coordinate religious services and Jewish celebrations which can attract them. Such a program coordinator must have a budget for supplies, publicity, and special events. We need religious texts in Russian translation and transliteration for them to join in the services. In addition, we need to be able to underwrite the costs of integrating the children of new immigrants into our on-going religious school until they are ready to pay their own way as members in good standing, costs which we hope the Bureau of Jewish Education will underwrite in the form of scholarships.

F. Evaluation-- As stated in D-growth of enrollment, membership, leadership figures.

G.Future funding- Those programs already funded by the Bureau of Jewish Education will

be continued under the same policy. Costs of the program coordinator should eventually be offset by membership fees as new Russians become veterans and begin to affiliate.

H. This program is approved by the Rabbi and President of the Temple.

III Formal proposal to Executive of Hollywood Temple Beth El to adopt program

To: Mr. Joe Heller and Executive of Hollywood Temple Beth El

Hollywood Temple Beth El has been granted special funding from the Council on Jewish Life of the Jewish Federation Council of Greater Los Angeles and the Jewish Community Foundation for hiring a Russian program coordinator, in recognition of the unique role we can play in integrating the Russian speaking community into the mainstream of American Jewish synagogue life. As is obvious, the Russian -emigre community, numbering 10's of thousands is the largest as yet unaffiliated Jewish public in the Hollywood-West Hollywood area, and forms the natural audience for the largest body of future membership, if properly cuiltivated.

The grant is for \$10,000, to be used solely for salary(presumably inclusive of taxes and insurances). We would be responsible for providing whatever funding would is neccessary to be effective.

We now must begin to seek a Russian -speaking program coordinator to take oversee the on-going activities which we have initiated here, work with the families of those already participating and who have displayed interest in involvement in HTBE, and with their involvement, reach out to the local Russian community(both new immigrants and veterans.

The candidate should be a native Russian speaker, also fluent in English, who has a general knowledge of Jewish practice and thought and familiarity with American Jewish life, and a potential leadership type. Presumably, the \$10,000 can provide us with a 1/4 to half time worker. The prime candidate is someone who has been here long enough that a part time position is sufficient at present for their needs. As added incentive, the position can grow as enough Russians join on as members, thereby off-setting costs for the program coordinator.

Furthermore, someone capable of community work, whose English is suffciently good can also take on a second job, for membership growth and programming in general.

Objectives:

To create and lead religious, educational and cultural activities which introduce new immigrants to Jewish life in USA, in consonance with the ideals of Conservative Judaism, respecting Jewish observances while emphasizing open intellectual inquiry and respect for other streams in the community.

To integrate new immigrants into community of Hollywood Temple Beth El.

To cultivate potential leaders among the Russian community.

To involve veteran Russian Jews in Hollywood Temple Beth El.

Tasks:

1) Work with the Rabbi in establishing a task force for Russian outreach, to consist of veteran members of the congregation and new Russian members, who will assist in logistics of various special events, i. e. Shabbat dinners, concerts. Task force will advise the synagogue leadership on best approaches to involving and integrating new Russians to the congregation and obtain leadership support for projects. Task force chairperson will

coordinate with lay leadership of various synagogue committees: i.e, program,membership, School, Sisterhood, Men's Club.

- 2) Coordinate between Rabbi and synagogue leadership and the agencies which work with the synagogue in acculturation projects:
- a)Bureau of Jewish Education Emigre department head, Esther Krisman, associate, Margie Zinman, and New Immigrant Religious school project teachers.
 - b)Bar Mitzah course instructor, Cantor Ralph Goren.
- c)Other Federation offices:Immigration and Acculturation,Council on Jewish Life,Jewish Family Service, Jewish Vocational Service.
- 3) Form connections and obtain support for programs from from individuals and organizations in the established Russian community: i.e, American Association of Soviet Jewish Emigres, Panorama, KMNB Russian Radio.
 - 4) Work with Rabbi in teaching adults and youth.
- 5) Coordinate and lead services in conjunction with the Rabbi using basic elements of the liturgy in Hebrew and explanation in Russian, with goal of integrating participants into main services.
- 6) Prepare bulletin for distribution to the Russian community covering activities offered, create or find appropriate material in Russian language and transliterations for use in activities.
 - 7) Other projects and activities as shall be developed over the course of the program.

Conditions of Remuneration:

Total remuneration: \$10,000, a self-employed, for 1992-93 year, beginning October 1, 1992 continuing through Sept.30,1993. To be disbursed bi-monthly, over the course of the year. One month in the summer shall be designated as a vacation month.

All taxes and health payments are responsibility of the outreach coordinator. A portion of the remuneration can be designated for business and travel costs, as per synagogue's tax adviser.

Coordinator shall be directly responsible to the Rabbi. Budget for programs shall be

I greatly appreciate your sending me the volume on the teaching of Rav Kook, zt"I . I had served in Israel as the Director of the Central Institute for Jewish Studies for the Histadrut at Bet Berl, and had opportunity to become acquainted with several contributors to the volume.

This is a felicitous circumstance, since I have been informed that your organization has sponsored various projects of outreach to the Russian Jewish Community in the Los Angeles area, and it was suggested to me that I contact you.

Hollywood Temple Beth El is at the centerof the influx of new Russians, as well as the veteran Russian settlement in Los Angeles.

We have served, in the past, as the host to the Russian Community Center, and recently, to an experimental Hebrew School and Bar Mitzvah program under the auspices of the Bureau of Jewish Education. We, on our part have extended special introductory membership offers to these new Russian families and have begun to integrate them into the congregation.

In light of our prime location and activities, the Council of Jewish Life of the Jewish Federation has recently given us a grant for the hiring of a part time outreach coordinator. However, this covers salary only, and we have no spare fat on our budget to allow for serious outreach activities. These would include subsidies for Shabbat dinners, guest lectureships, publications and advertising in the local Russian language media, basic Jewish books such as siddur, humash in Russian translation and transliteration, a Judaica resource library in Russian.

We have begun to meet the first and second goals, and to some extent, the thrid goal as well.

Answer to question #2: Were your goals realistic

These goals are realistic, with the understanding that these are to be developed over a period of time, because we are faced with changing the mind-set of a population historically distanced from any contact with Judaism and the rest of the Jewish world.

Question # 3: When did your program start?

Our program has been in effect, through our cooperation with the Bureau of Jewish Education, since 1991, through our Bar Mitzvah program for Russian youth and the Bureau's Sunday School project which meets in our building.

We suffered two major delays in our implementation. First, from the time of notification of official grant approval, which only came in the summer, we were not in a position to begin searching for the proper candidate till after summer vacations.

It has proved to be very difficult to find qualified Russian outrecah workers with a combination of some Jewish knowledge, experience in the local Russian community, and an ability to work effectively.

After extensive interviews through August and September, Eliyahu Abramson, a graduate student in history, was hired as our outreach worker.. For a variety of reasons, he was not able to carry out our expectations effectively and was released from the position in the beginning of January, 1993.

Once again, we began the search process, and settled on Leonid Litvachuk. Mr. Litvachuk had been a teacher of Mathematics Education on college and high school level in Russia, has been here for two years, and was actively involved both in Russia and here in Jewish programs, in particular with the Outreach program at Young Israel of Melrose.

Litvachuk has been working with us since April 1.

Introduction by Rabbi Norbert Weinberg to the programs for absorption of Jews from the former Soviet Union

The Jews of the former Soviet Union (Russia, Ukraine, Moldova, Belarus, Georgia and Central Asia) since the Communist Revolution of 1918, experienced particular hardships from several ends:

- 1) A historic resentment of Jews in higher positions, dating back to Tsarist times
- 2) A political policy eliminating religion from both the public and private sphere, enforced, in some cases by fellow Jews, the Yevsektsia.
- 3) A policy to disconnect Jews from their fellow Jews worldwide, in particular in regards to Zionism and Israel, and concomitant, the gradual elimination of Jewish ethnic identity, again, a continuation of older Russian Tsarist policies.

As a result, Jews of the pre- WW II Soviet territories, over the course of 70 years, were distanced from contact with Jewry outside, Jewish observance was repressed, resulting in a disconnect between the Jew qua Judaism and the Jew as Soviet citizen. The same happened, but to a lesser degree, to the Jews of the territories absorbed into the Soviet Union after WWII, such as western Ukraine.

Starting in the late 1960's, pressure built up, both by Jews inside the Soviet Union, and by Jews outside, to allow Jews to leave. There was a small movement of Jews out, under great difficulty, over the decades leading up to the fall of the Iron Curtain. With that "Tear the Wall Down" moment, the great majority of Jews finally were able to leave, seeking better opportunities. Many came to the USA, and Los Angeles became a favorite destination, with West Hollywood and the area around Hollywood Temple Beth El, becoming a significant hub.

Hollywood Temple Beth El became one of the hubs of service for these newcomers, and one of the key elements was to help them absorb life in this "Brave New World" in which one could be free to be a Jew and live as a Jew, without questions asked. Through the portals of the synagogue came former Party officials, former Soviet missile and submarine

experts, former Soviet journalists, and former popular Soviet entertainers and movie stars!

These are from my personal records are regarding the services Hollywood Temple Beth El provided to the newly arrived refugees from the former Soviet Union. This reflects activities in 1993. The Jewish Federation of Los Angeles allocated a total of \$15,000 spread over two years.

Question #1:

Our goals are four-fold.

- 1)To create and lead religious, educational and cultural activities which introduce new immigrants to Jewish life in USA, in consonance with the ideals of Conservative Judaism, respecting Jewish observances while emphasizing open intellectual inquiry and respect for other streams in the community.
 - 2)To integrate new immigrants into community of Hollywood Temple Beth El.
 - 3)To cultivate potential leaders among the Russian community.
 - 4)To involve veteran Russian Jews in Hollywood Temple Beth El.

We have begun to meet the first and second goals, and to some extent, the third goal as well.

Question #2: Were your goals realistic

These goals are realistic, with the understanding that these are to be developed over a period of time, because we are faced with changing the mind-set of a population historically distanced from any contact with Judaism and the rest of the Jewish world.

Question # 3: When did your program start?

Our program has been in effect, through our cooperation with the Bureau of Jewish Education, since 1991, through our Bar Mitzvah program for Russian youth and the Bureau's Sunday School project which meets in our building.

We suffered two major delays in utilizing an outreach worker. First, from the time of notification of official grant approval, which only came in the summer, we were not in a position to begin searching for the proper candidate till after summer vacations.

It has proved to be very difficult to find qualified Russian outreach workers with a combination of some Jewish knowledge, experience in the local Russian community, and an ability to work effectively.

After extensive interviews with over a dozen candidates, through August and September, Eliyahu Abramson, a graduate student in history, was hired as our outreach worker. For a variety of reasons, he was not able to carry out our expectations effectively and was released from the position in the beginning of January, 1993.

Once again, we began the search process, and settled on Leonid Litvachuk. Mr. Litvachuk had been a teacher of Mathematics Education on college and high school level in Russia, has been here for two years, and was actively involved both in Russia and here in Jewish programs, in particular with the Outreach program at Young Israel of Melrose.

Litvachuk has been working with us since April 1.

Despite these two setbacks, we have been able to undertake some significant activities, beginning immediately after the holidays in the fall of this year. I have personally supervised these activities when we did not have an outreach worker.

Results of meeting Dec 10 with Leah Archibald, assistance to West Hollywood Councilman, Paul Koretz, and Daphne Dennis, Head of Social Services.

Councilmen Heilman, Koretz, and Land agreed to establish task force to meet needs of families in West Hollywood, especially of Russian new immigrant fmailies. One key area of interest is support or establishment of after schooll educational activities. Two follow up meetings in Jan and Feb --we will be invited to attend.

Very likely that major funding will be available through recreation and family services budgets. Some of this funding could be applied to after-school educational activities at Hollywood Temple Beth El for english, math, music and arts classes.

It is suggested that we look to California Community Foundation for search for grants.

In the interim, it is possible that if we set up our own program, the city might be able to provide transportation from Laurel and Gardner schools to the synagogue.

Enclosed is an extensive evaluation of our Soviet Jewry program, funded by a grant from the Council on Jewish Life.

I recognize that we are not eligible for any extension of teh grant moneys, and our financial situation prevents us from continuing with our outreach worker. However, we will be continuing with much of our activities, run by volunteers. I believe the evaluation will be of benefit for future planning of programs with Russian immigrants.

The key problems are:

- 1) The difficulty to find a qualified worker for a synagogue.
- 2) The difficulty in moving beyond free participation to active participation on the part of the immigrant community, whether because of continued financial troubles, or lack of commitment.

Synagogue Funding Evaluation

Question #1:

Have program objectives been met.

Our goals were four-fold:

- 1)To create and lead religious, educational and cultural activities which introduce new immigrants to Jewish life in USA, in consonance with the ideals of Conservative Judaism, respecting Jewish observances while emphasizing open intellectual inquiry and respect for other streams in the community.
- 2)To integrate new immigrants into community of Hollywood Temple Beth El.
 - 3)To cultivate potential leaders among the Russian community.
 - 4)To involve veteran Russian Jews in Hollywood Temple Beth El.

We have met these only partially. We have created programs of

religious education, both through our own activities, and relying on programs of the Bureau of Jewish Education held in our facilities. Several families from the school programs have become members, with children registered in the Hebrew School and volunteering in our office or other aspects of the Temple. A good number of the senior citizens among them have become regular participants at Shabbat worship, and our Shammes has been effective in enlisting some as "Tenth" at minyan. It is very difficult, however, to translate this into a membership which, in any significant number. can actually give support in turn to the synagogue and help defray our operating expenses.

We have made the Temple available to the Association for Soviet Jewish Emigres for an emergency meeting in regards to social security for immigrants; 1600 senior citizens showed up. We have had great success in making our main sanctuary available for special concerts by Russian artists, run by outside enterpreneurs, wherein over 1000 people show up each time.

We have found it difficult to create a leadership out of the new immigrants, presumably because their experience of acculturation is itself overwhelming. Our greatest need, however, is to involve the veteran Russian community in the Temple. To this end, we have begun discussions with the Association for Soviet Jewish Emigres for greater involvement.

Ouestion #2-Methods

We did not rely on any preset timeline, but have run our activities for the most part on a regular basis. Those programs that did not succeed in drawing attendance were closed down shortly; others, with good attendance, have been maintained.

We have reached our general geographgic area, and have utilized volunteers in teaching English synagogue Hebrew with great success. Our first professional staffer was released from the position shortly after he began; our current staffer, Leonid Litvachuk, has carried out a consistent effort. Unfortunately, we had not been able to find someone of Russian origin who has both Judaic knowledge, familiarity with the synagogue, and a background in volunteer organization. We have just recently been fortunate to obtain the voluntary services of Yelena Yustis, recently form the Soviet Union, and we can highly recommend her for such work in the future, if funding were to be made available.

Our two other resources community resources have been very effective-namely, the Sunday program for children as well as the grant for the Bar Mitzvah class, both form the BJE.

All funds were spent, as specified in the grant, on salary for the outreach worker.

Unforntuantely, the grant specified salary only, and we did

not have our own finances to better underwrite programming expenses.

It covers a general introduction to Jewish life, with presumption that, in following year, they will be mainstreamed into a Hebrew school program. (This has begun to happen). - 3) English Discussion club led by volunteers Natalie Bykova and Sarah Lvovskaya on beginning and advanced levels on Sundays, 11:00-12:00 and our outreach worker, Leonid Litvachuk ,leads a discussion group on American Jewish Life.
- 4) Basic Synagigue Hebrew--Every Sunday, we have a short course on Hebrew for all our participants, led by Yelena Yustis, a volunteer. Yelena is a recent arrival from Russia who studied Hebrew there.

We have held the following special events:

- 1) Slichot services-we held a special pre-slichot music concert with Russian musicians, Natalie Vaiman and Irina Nagorskaya. We have used Russian musicians at various special functions as well.
- 2) Several Shabbat Dinners--
- Service and dinner in conjunction with the Bureau of Jewish Education with their study group participants, Russian members of HTBE, a families enrolled in Sunday program.
- 3)Community Chanukkah celebration(Dec. 92) with Larissa Eryomina, noted Russian actress, featuring two entertainment teams of new immigrants, Alex & Jane Sinitsa and the Troyan family.
- 4) On numerous occasions, we run discussions, led by the Rabbi, in English, with simultaneous Russian translation, for our Sunday participants. Through the Bureau of Jewish Education, we recently hosted a model Seder for adults.
- 5)We have held several sessions of the American Jewish Life course of the BJE and are planning to run another series shortly.

The following activities were of short run duration:

- 1) Children's Group: Math for ages 8-10. Despite much expectation, parents were not willing to pay fees of \$5/ session.
- 4) Americanization Class- with Alex Binstock- 25 students showed up at first session. Were willing to attend for free, but not for fee.

Agreed to pay \$2 per session, but did not show up again. (These participants are not working people, but adults who came here too young for social security benefits, but too old to be hired in California job market (ages 55-65). They are on welfare, and there payments have been cut.

5) Cinema group-- Ran through the summer- 30 people in attendance--Never grew beyond an entertainment program and it was not financially feasible to keep the building open for this activity.

3 Evaluation:

- 1) Attendance--this was an easy factor to evaluate. Regular attendance at the Sunday sessions, with an extra session in easy English led by Mr. Litvachuk averaged 50-60 senior citizens, plus approximately 25 children in the Sunday School program and 4 in the Bar Mitzvah group. (It has been as high as 14 in previous years).
- 2) In terms of paid membership, response has been weak. There is no response at all to pay for quality programs, even on a nominal basis. The elderly immigrants clearly are severely limited in the ability to pay even minimal fees, and the younger families, while perhaps earning income, have decided to put their money on their immediate needs first. We are also dealing with a community which has still been used to fully subsidized services in all other aspects of life and for whom voluntary association is still a foreign notion.

3) Analysis of Russian prorgam:

According to our outreach director, there are other limitations of dealing with LA's Russian Jewish community--in addition to the basic absence of Jewish training and loyalty to Jewish tradition which was result of 70 years of Soviet indoctrination. The local community is a working class public for the most part, not the academics (from Moscow-Leningrad) who make up Russian communities in New York or other US cities. 85% are from Kishinev(Moldova) or-Kiev-Odessa in Ukraine and this affects their interests and needs. Why so--Anti-semitism in Ukraine was blatant, Jews could not get better jobs, promotions, could not get into academic studies. Therefore, they entered either into small businesses (cottage industries) or, if they were "Engineers", that meant, for the most, technicians or mechanics. He claims that their interest in intellectual or spritual matters is low. Life in America also affects the intellectual community here- within a few years, they too discover that money talks. For example- new arrivals still go to concerts at Hollywood Bowl, but after a few years they stop that too.

An outreach program must meet a specific need, for which Russian immigrants are willing to pay.

One such suggestion is a significant need in this area for extended care for grade school children. This extended care would incorporate guided assistance in homework and school studies, as well as art, music activities-It would be billed as a Learning Enrichment center. In order to succeed it must not be seen as a Russian program but as a general study program for area youngsters. It would run weekdays, 3:30-6:00, and would need a staff of credentialed teachers of Russian and American background.

Financing could be through fees and cover expenses of teachers, administrators, overhead, as well as possible government funding.

We have followed up this idea with one meeting with representatives of the City of West Hollywood, who have expressed an interest. However, this is a project far greater than we are capable of undertaking with our current resources. The Enigre Department could conceivably undertake such a project.

Question #4

We have recieve our funding from the Bureau for its sponsored programs. We did not , however, receive any kind of fees from the participants. This has killed those programs for which we could not have volunteers work for us.

We have now spent all of the moneys from the Council on Jewish Life. This totaled \$10,000 the first year and \$5,000 the second year. This will have been spent in full by the first week of May. Due to the severe financial crisis our Temple is facing, we will not be able to retain Mr. Litvachuk beyond that date. We will, however, continue with our weekly classes, led by our volunteers. At the same time, we will explore alternative activities for Russian immigrants, perhaps in conjunction with the Association for Soviet Jewish Emigres.

Question #5

Clearly we have a consistent good working relationship with the different Federation agencies involved with Russian immigrantsi.e, the Council on Jewish Life, the Emigre Dept of the BJE, the Immigration & Absorption office.

We do not have a UJF campaign.per se. However, we have always dedicated a Shabbat to Tzedakah in line with UJF Super Sunday. Our current financial difficulties do not enable us to undertake any more serious campaigning at this stage.

In regards to Synagogue- Federation relationships, since both institutions, in the Los Angeles area have been facing serious funding crises, I believe that the Federation may well be in a position to serve the synagogues, through direct input on demographics, membership campaign, leadership training. In these ways, the synagogues can be strengthened, and in turn, create potential leadership for collective commual leadership.

Question #6-

Surely there are apsects which can be applied in other synagogues with heavy Jewish population, and we would be happy to share information.

In fairness to Leonid, we should prepare a letter to him explaining that the position of Russian Outreach Director is ending.

Dear Leonid,

As you know, the position of Outreach Director for Russian Immigrants was contingent upon funding by the Council on Jewish LIfe of the Jewish Federation of Greater Los Angeles.

That funding originally was expected to have been for three years, in which the second year would have been two-thirds, and the third year, only one -third, the base grant. However, due to changes in the nature of the council's funding, only a second year was funded, and again, only to 1/2 the original amount.

That total funding, of \$15,000 will have been expended by the last payment to you, in April, with a balance of \$332, which will be paid for the first week of work in May. (You can add: we will cover you through the month of May)

As you understood from Joe Heller, the hopes were that the Russian participants would become members in full, or that programming could be created which would help cover your payment, in order to continue the position after the end of the funding. Unfortunately, that has not been feasible.

We appreciate your good efforts, and you have been a good asset to us, in many ways, during this period. We are sorry, indeed, that our financial situation does not allows us to continue with your position when these grant moneys are paid out.

From: Rabbi Norbert Weinberg Re: Meeting of April 13,1994

1) Nature of working with Russina community discussed. Up till now, under Leonid LItvachuk as outreach director, we have succeded only in drawing in elderly immigrants on limited income, who are not capable of becoming active supporters of the synagogue, either in income, or in volunteer efforts.

We have not had success in drawing in veteran Russians, who are self-supporting.

- 2) The Association of Soviet Jewish Emigres is funded, by the city of West Hollywood, and has significant contacts in the established Russian community of veteran members who are currently active in other synagogues (VBS, Stephen Wise, etc) but would become active here if they felt there was programming offered of interest to them and not under the auspices of Chabad.
- 3) The current President, Eugene Levin, is an active member of VBS, understands the nature of synagogue affiliation, unlike his predecessor, Mr. Makaron.
- 4) The Association is interested in active involvement with HTBE, in activities that would benefit us both, in terms of members and in terms of potential income.
- 5) Through Miriam Prum hess, we have discovered that we are eligible for City of West Hollywood full funding for children of new immigrants to our nursery school. Harriet has informed me that the nursery school has at present 6-7 available spaces, which could be very shortly filled in this way. Mr. Levin has been given the details about the nursery, and will begin to convass the new immigrant community for potential candidates. This will give the synagogue an immediate extra cash income of 3,000-5,000 per child, a potential of an additional\$ 18,000-30,000.
- 6) I am recommending the following format of events:
- a) Series of concerts, at relatively low cost, profits to be split between HTBE and the Association.

The Association will arrange for the concert, advertising, and sale of tickets. This would be quality entertainment for American as well as Russian audiences.

By past experience, up to 600 people easily show up for such concerts, at \$10 ticket=\$6,000.Expenses for the concert would be

kept modest(entertainer, Alexander Zhirov, noted copncert pianist, at low cost, free advertsing in Russian Panorama, radio, TV, etc) Even with expenses of up to \$2500, leaves a balnce of \$3500. Split equally= \$1700.

Possible dates: Sunday evenings, 5:00-7:00 PM .May 22, June 5, June 19, June 26. Based on first experience, can suggest follow up concerts in August, avoid Sept. holidays, go to October, etc on a monthly basis. This can become a source of regular income to the Temple. Small scale Cabaret-type events can also be carried out, which we are not capable of doing, but the Association can put on to the benefit of both of us.

b) Follow up concert with a series of Friday evening services, which would copy the Creative Arts Service, but utlize local Russian talent. i.e.. A noted Russian woman vocalist who is also a cantor, Svetlana Portnanskaya, others would provide music, readings in English, Russian. Temple Israel of Hollywood added 100 paying Russian members to its list in the past years, primarily because they have a good evening service, and make translation available. Even at a reduced rate of \$200 per member, that would be an additional \$20,000 a year.

I suggest August 12 or 19 as a first time, coming two-three weeks before High Holy Days. Cantor Erman would also be involved. We would then follow up with a publicized evening of music before slichot., on Saturday, August 27. This would give us excellent puiblicity before the high holy days and promotion for sale of tickets.

Follow up to meeting of April 13,1994

Meeting with Eugene Levin and Svetlana Portnyanskaya.

- 1) Portnanskaya is a noted Russian born vocalist who has cantorial training with Cantor Fordis, appears frequently on local Russian television. She is willing to work with HTBE and the ASJE to put together concert and other programs.
- 2) Agreed-- We will confirm one of the following dates for a concert in Sanctuary
 - a) Sunday, May 22, at 5 or 7 PM
 - b) Sunday, June 5 at 4:30(to conclude by 6:30, because we will have another program that evening at 7:00 for our members)
 - c)Sunday, June 26 at 5 or 7 PM
- 3) Contents: Musical program for 1 1/2 hours of classic and popular song and music, with Portnyanskaya and three or four other musicians, geared to Russian audience tastes.
- 4) ASJE will handle publicity, advertising, ticket sales to Russian speaking public. HTBE will publicize in anglo-Jewish and local press. ASJE will arrange for technicians, musicians, etc. Expenses to be paid out of procedes of ticket sales. No up front expenses.

5) Estimnated expenses and income

Expenses:

Piano moving \$150, sound equipment-\$200, ushers-\$75, security-\$125, valet-\$200

Performers-\$1500 maximum total, 200-300 each performer.

Promotion-

flyers, posters.\$250.

tickets-\$200-reserved seating

Advertsiing in Panorama, Radio, TV-\$450.

Total projected expenses--\$3,000

Income:

sale of 600 tickets(past attendance has suggested paying audiences of up to 800 and above). 100 @ \$20, 200 @ \$15, 300 @ \$10. Total projected sale \$7,000

Difference, \$4,000 to be split between the two associations.(\$2000 each or more).

Event is sponsored by Hollywood Temple Beth El, and is therefore covered by our insurance. (I have checked with Bachenheimer).

6) On the basis of this first attempt, we will judge possibility of future joint events. Ten such events a year can bring the Temple an additional \$20,000 income.

7) Future program;

Slichot services--Saturday night, August 27, would be sponsored jointly. Starting time: 9:30 PM.

Entertainment portion-Svetlana Portnyanskaya and accompanist.

She will volunteer her services.

10:30 PM Social hour, refreshments, sponsored by ASJE

11:00 PM Slichot service--Rabbi and Cantor.

ASJE will get free publicity in Russian media. We will coordinate this with our advertising in Russian media as a lead item for High Holy Day ticket sales.

8) I have discussed with Cantor Erman possibility of incorporating Portnanskaya into High Holy days service as member of choir, with some solo participation. He has already offered the positions to his previous years vocalists, but is still awaitinga response from his soprano. Should she not be available, he will contact Portnyanskaya. This too will serve as a positive attraction for additional high-holy days ticket sales and membership.

9) In the fall, we will begin the process of creating our own "Creative Arts service" sharibng the effort with the ASJE.

1) Re May 18-- Please be sure to contact Alex Polovets and anyone else whom you believe is needed for our program on May 18, at 7:30 PM. Also, please make sure that we can get people in the

audience who are Russian immigrants.

2) Cultural center:

I have spoken with Andrea from Council of Jewish Life at Federation. We might still be able to get a grant for this year.

We would need to prepare a proposal for Jewish Cultural Center, sponsored by the Association and Hollywood Temple Beth El, for funding for such a center. The main expense would be to cover janitorial and maintanence overhead, since otherwise our building is closed at night--That is a minimum \$100 a night for our classrooms, . One night a week or one Sunday morning , for 40 weeks(excluding holidays) is \$4000. This would be the minimum amount we would need to request. Since it would be a joint venture, and might be considered a new project, there might be a possibility of having it approved, even though we have passed the deadline for this year. Otherwise, we will have to wait for next year. Might it be possible to get such a grant from the city of West Hollywood?

Tuesday nights is definitely impossible on a regular basis, as there are too many complicating factors.

4) Impressarios

I have spoken to our insurance agent. Any outside impresario would need independant liability coverage. This costs about \$1000

However, if the event is sponsored and advertised as a Hollywood Temple Event, to Hollywood Temple members, the our liability would cover it.

I want to make the following recommendation. I do this with the consideration that I want fewer programs, with security:

- a) We jointly host the event. All publicity is in our names.
- b) We will agree on four such events during the year. The impressario will have to coordinate with you and us, and will need to put rental money in advance to reserve the date. He will place our names as hosting the event and give us copies of his flyer, in English, to put in our publicity. Also, he will prepare a brief notice to go to the Jewish anglo-press as well as local papers. Thereby, this is certifiably a Temple event, and would be protected by our insurance.

c)We would reduce the rate to \$1500 for use of the sanctuary (1100 seats) on Saturday nights or \$500 for use of the Garden Room on weeknights, without use of kitchen(when we have less catering business--seats 390 maximum, at tables) This is ideal for cabaret settings--

d) Since we have success in getting impressarios who do have

insurance and can afford our regular fees, we can not publicize this reduced rate or arrangement in any way. The arrangement would have to go through the Association, and you would need to decide who and what event is under your auspices. I also believe that the Association should also make some arrangement whereby it, too, could get some extra income from this, such as having reserved first row seating for patrons, whose tickets would go to the Association as a benefit. Or, get a block of tickets to sell, and keep the procedes.

e) Both of our organizations avoid the logistics nightmare of arranging and hosting a concert.

To whom it may concern:

Leonid Litvachuk worked for Hollywood Temple Beth El from April 1993 till May 1994 as Director of Outreach to Russian Immigrants, under a special one-time grant from the Council on Jewish Life of the Jewish Federation-Council of Greater Los Angeles and the Jewish Community Foundation.

His task was to facilitate the acculturation of new Jewish immigrants from Russia and other republics of the former Soviet Union into American civil life and the Jewish heritage.

To this goal , he organized and taught classes on English as a Second Language, American governmental and legal system, the Constitution, American history, and common customs and practices in American life. He also taught math bilingually to recently arrived Russian immigrant children, ages 6-10 . He also participated in programming activities within the framework of the synagogue in conjunction with me as the Rabbi.

His activities were noted in a recent feature article in the

To Jule from Rabbi: November 23, 1994

This is a summary of my meeting with Eugene Levin, of the Association of Soviet Jewish Emigres (phone # 213-969-0919), and Sy Frumkin, noted LA Soviet Jewish activist.

They have received a grant from the Federation for two courses, one in the valley one in this side of town, for New Immigrants on Judaism and Russian Jewish history. They would like to hold these classes here, twice a week for two hours, somewhere between 1-4 PM.

They have access to Plummer park for free form the city of West Holywood. However, we are a preferable location.

They do not have funds for rent, and the Federation grant requires that they do not take fees from the students. However, in exchange, we can request free publicity for all Temple affairs in Russian on Russian language radio as well as extra publicity in the local Russian newspaper, Panorama.

We can also dove-tail with another program, which reinstates what we had already done last year, English language classes. We have a volunteer, Maryiam Millstein, who is available to teach in the time slot preceding this lecture series. Since this is a neccessity, and Chabad charges \$10 a month for their classes, we can easily charge \$5 a month. If we get 20 people regularly, we will have \$20 a week, \$80 a month, \$1000 a year for our efforts.

We can use the chapel for this purpose. If they need a blackboard, we can ask them to provide us with one as part of their

condition. Also, we can ask them to take responsibility for clean up.
