The <u>Classification</u> of Occupations in Romania - occupation level (six characters), as approved by way of the <u>Order</u> of the Minister of Labour, Family and Social Protection and of the President of the National Institute of Statistics no. 1.832/856/2011, published in the Official Gazette of Romania, Part I, no. 561 of 8 August 2011, as subsequently amended and supplemented, is amended and supplemented with the new occupations practiced within the national economy, provided for in the list in the <u>Annex</u> which is an integral part of this Order.

The occupation "Specialist in Qualification Systems" is renamed as "Occupational Analyst" and the same code 242313 is kept in the basic group 2423 Specialists in the field of Human Resources and Personnel.

The occupation "Enterprise Expert Evaluator" is renamed as "Authorised Evaluator" and the same code 241251 is kept in the basic group 2412 Specialist Consultants in the field of Finance and Investment.

The occupation "Immovable Property Expert Evaluator" code 241252 is removed from the basic group 2412 Specialist Consultants in the field of Finance and Investment.

The occupation "Real Estate Expert Evaluator" code 241253 is removed from the basic group 2412 Specialist Consultants in the field of Finance and Investment.

The occupation "Financial Assets Expert Evaluator" code 241254 is removed from the basic group 2412 Specialist Consultants in the field of Finance and Investment.

The occupation "Legal Consultant" code 261102 is removed from the basic group 2611 Lawyers.
