CONSTITUTION

Article I: Name and Legal Foundation

1. The name of the institution is **Oxford Numerology University®**, hereinafter referred to as "the University".
2. The University operates under the authority of **Oxford Numerology Society**, initially founded in Bucharest, Romania, in 2004 (Registration No. 16397935) and legally registered in the United Kingdom in 2023 (Company No. 14923926).

Article II: Mission and Objectives

The mission of Oxford Numerology University® is to advance academic excellence in the study and professional practice of numerology through research, education, and international collaboration. The University aims to:

1. Provide rigorous training and certification programmes in the field of numerology.
2. Deliver open and distance learning as the primary method of educational delivery.
3. Support the development of numerology as a recognised professional discipline, aligned with the European Occupational Standard COR 516102.
4. Foster scientific and integrative approaches to holistic education.
5. Encourage research, innovation, and global dialogue in numerological studies.

Article III: Governance and Academic Structure

1. The University is governed by the **Board of Honor**, chaired by the **Founding Dean**, Prof. Dr. Diana Metiu.
2. The academic leadership is coordinated by the **General Secretary** of Oxford Numerology University®, who is also the CEO of Oxford Numerology Society (UK).
3. The University comprises distinct academic levels, including Certified Numerologist, Counsellor Numerologist, Trainer Numerologist, Coach Numerologist, Professor Numerologist, and Master Numerologist.
4. Programmes are designed in accordance with the COR 516102 Standard and are supervised by academic coordinators, course trainers, and certified examiners.

5. The Board of Honor includes the following members:

6. Ordinary decisions of the Board of Honor shall be adopted by a simple majority vote of its members, unless otherwise specified in this Constitution.

Article IV: Educational Delivery and Quality Assurance

1. The University delivers education primarily through open and distance learning (ODL), using virtual platforms, live video sessions, asynchronous content, and supervised practice.
2. Each academic year includes theoretical instruction, guided practice, independent study, and two formal assessments.
3. Each academic year comprises **1,500 hours** of structured learning activities. Upon successful completion of each academic year, students are awarded a distinct diploma corresponding to their academic level.
4. Upon completion of the full six-year programme, students will have accumulated a total of **9,000 academic hours**, equivalent to **360 ECTS credits** (based on the standard conversion of 25 hours per ECTS credit). This academic volume is comparable to the combined total of undergraduate and postgraduate (MBA-level) study within the European Higher Education Area.
5. The University commits to continuous internal evaluation and external accreditation processes with international academic and professional bodies.

Article V: Language of Instruction and International Collaboration

1. Courses are delivered in **English** and **Romanian**, with **Spanish** to be added from 2026, **French** from 2027, and **Italian** from 2028.

2. The University actively seeks collaboration with international institutions and is pursuing accreditation with AAOU, IPHM (UK), IICT (Australia), AADP (USA), and other relevant bodies.

Article VI: Amendments

1. This Constitution may be amended by a three-fourths majority vote of the Board of Honor, provided that such amendments are in alignment with the vision and standards of the University and its founding society.
2. The Founding Dean holds the right to veto any proposed amendment, thereby preventing its adoption regardless of majority vote.
3. If the Founding Dean assumes the role of Rector, once the University expands to include multiple faculties of numerology, such as Chaldean, Kabbalistic, and others beyond the Pythagorean, the right of veto shall be retained in that capacity.
4. However, any future Dean appointed after the transition shall not inherit this veto power.

Article VII: Academic Autonomy

1. The University upholds full academic freedom in designing its curricula, selecting its faculty, and publishing research following its ethical charter.
2. The University remains independent of political, religious, or commercial influence.

Article VIII: Admissions and Ethical Commitment

1. The University admits students regardless of nationality, gender, ethnicity, or belief.
2. All members of the academic community are expected to uphold the ethical standards outlined in the charter's *Principles of the Modern Numerologist*.

Article IX: Founding Authority

1. Oxford Numerology University® was founded as the sole academic endeavour of Oxford Numerology Society. While the Society retains its role as the legal founding body, all academic decisions and institutional governance are vested in the Board of Honor.
2. Strategic transformations such as constitutional revisions or international expansions shall be subject to joint alignment between the Society and the University's governing structures.

3. This alignment is structurally guaranteed by the constitutional provision that all shareholders of Oxford Numerology Society automatically and permanently hold a de jure seat on the Board of Honor, without the possibility of removal or exclusion.

Article X: Periodic Review

1. This Constitution shall be formally reviewed every five years by the Board of Honor to ensure its continued relevance and alignment with the University's academic mission and strategic growth.

Article XI: Enactment

1. The foundational decision to establish Oxford Numerology University® was formally made on 8 June 2023 through the constitutional act of Oxford Numerology Society, signed by its two shareholders, Prof. Dr. Diana Metiu and Prof. Cătălin Costache.
2. This act defined the governance structure of the future university and named the initial members of the Board of Honor.
3. The Constitution was officially approved by the newly formed Board of Honor on 28 June 2023.
