Early Enrollment: Returning Students, by 12/11/24

**\$11,000** (non-refundable deposit of \$2,500 must be received on or before 12/11/24)

Open Enrollment: All Students, 12/12/24-2/14/25

**\$12,000** (non-refundable deposit of \$3,500 must be received on or before 2/14/25)

Late Enrollment: All Students, after 2/14/25

**\$13,000** (non-refundable deposit of \$4,500 must be received upon student's acceptance)

Tuition payments are due on the 1<sup>st</sup> of each month. A \$25.00 late fee will be charged after the 15<sup>th</sup> of each month. Tuition not paid by the end of the month may result in the student's withdrawal from school. A \$35.00 fee will be charged for all checks returned by your bank for any reason.

Any student withdrawn due to lack of payment may be reinstated upon payment of late tuition plus a \$50 reinstatement fee. If you fail to comply with the monthly tuition payments, Frazer School has the right to file suit for breach of contract, open account, account stated, and any other available causes of action. In the event that Frazer School is forced to incur any expenses or attorney fees to collect any tuition payments owed by you, you agree that Frazer School is entitled to recover from you such expenses and attorney fees incurred in pre-suit collection efforts, litigation, appeal and post-judgement collection efforts. You further agree that the exclusive venue for any action related to the tuition payments shall be in the courts of Alachua County, Florida, and this agreement shall be governed by the laws of the state of Florida.
