

FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, FRISCO FASHION WEEK LLC, FASHION SHOW and EVENT ATTENDEE WAIVER AND RELEASE OF LIABILITY

This Waiver and Release of Liability ("Agreement") is entered into by and between the attendee ("Attendee") and FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, FRISCO FASHION WEEK LLC ("Company"), including its owners, directors, officers, employees, contractors, affiliates, sponsors, and venue partners (collectively, the "Released Parties").

1. EVENT DETAILS

FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, [events, gatherings, shows]

2. ASSUMPTION OF RISK

Attendee acknowledges that attending fashion show events involves inherent risks, including but not limited to: crowded environments, lighting and staging equipment, runway structures, elevated platforms, loud music, and potential physical injury. The attendee voluntarily assumes all risks associated with participation and attendance.

3. RELEASE OF LIABILITY

To the fullest extent permitted by law, Attendee hereby releases, waives, and discharges the Released Parties, FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, FRISCO FASHION WEEK LLC, from any and all claims, liabilities, damages, costs, or expenses (including attorney's fees) arising out of or related to any injury, loss, or damage sustained while attending the event, whether caused by negligence or otherwise.

4. MEDICAL ACKNOWLEDGMENT

Attendee certifies that they are physically able to attend the event and assume full responsibility for any medical conditions. In the event of an emergency, Attendee authorizes the Company to seek medical treatment on their behalf and agrees to be financially responsible for any such services.

5. PERSONAL PROPERTY

Attendee understands that the Company, FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, FRISCO FASHION WEEK LLC, is not responsible for lost, stolen, or damaged personal belongings brought to the event.

6. PHOTO, VIDEO & MEDIA RELEASE

Attendee grants the Company and its affiliates the irrevocable right to photograph, film, and record their likeness, image, voice, and appearance. Attendee agrees that such media may be used in perpetuity for promotional, marketing, social media, press, and commercial purposes without compensation.

7. CODE OF CONDUCT

The attendee agrees to behave in a respectful and lawful manner. FFW FRISCO FASHION WEEK ™, FRISCO FASHION WEEK ®, FRISCO FASHION WEEK LLC reserves the right to remove any individual from the event without refund for disruptive, unsafe, or inappropriate behavior.

8. NO REFUND POLICY

All ticket purchases are final. No refunds or exchanges will be issued.

9. INDEMNIFICATION

Attendee agrees to indemnify and hold harmless the Released Parties from any claims brought by third parties arising from Attendee's actions, behavior, or negligence during the event.

10. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas.

11. SEVERABILITY

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force and effect.

12. ACKNOWLEDGMENT

By purchasing the tickets for the fashion show or any other events, Attendee acknowledges that they have read, understood, and voluntarily agree to all terms of this Agreement.
