These protocols ensure maximum health protection for Mauritius, its inhabitants and travellers; but also provide tourists with a holiday experience that's as close to pre-pandemic conditions as possible. These protocols apply to all travellers entering Mauritius, including tourists, resident permit holders and Mauritians returning from abroad. Unvaccinated travellers must book a 14-night quarantine stay and you can find full details within our protocols booklet.

- To enter Mauritius, you must present a negative PCR test taken within 72 hours before departure
- It is mandatory to arrange health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)
- For hotel stays, a mandatory antigen test is required on arrival at your hotel (day 0) and again on day 5 of your stay. These will be chargeable, subject to your hotel policy
- You can explore the island after you receive a negative result from your antigen test on day 0

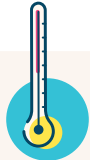

# Your journey to Mauritius

Fully vaccinated travellers can explore Mauritius from 1 October 2021 onwards

## 1. Pre-departure



Plan your holiday, staying in one of the island's hotels

Ensure you are fully vaccinated (unvaccinated guests must book a quarantine stay)

To enter Mauritius, you must present a negative PCR test taken within 72 hours before departure

Book health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)

## 4. At your hotel



On arrival at your hotel, you will undergo an antigen test

When you receive a negative test result, you can freely move around the hotel premises, enjoy the hotel facilities and explore our beautiful island

Depending on the length of your hotel stay, you will also be required to do an antigen test on day 5

Observe social distancing during your stay. You are allowed to remove your face mask on the beach, at the pool and when seated at a table in the restaurant or bar

Relax and enjoy your holiday!

## 2. Airport & flight



Mandatory documents required at check-in:

- A negative PCR test result obtained within 72 hours before departure
- Proof you have been fully vaccinated or official documentation proving that you have already had COVID-19 and have had a post-infection vaccination 14 days prior to travel (28 days if you have had Johnson & Johnson's Janssen vaccine)
- Proof of health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)

Wear a mask covering your nose and mouth throughout the flight, unless when eating or drinking, and disinfect your hands regularly

Fill out the passenger locator form and the health self-declaration form and hand these to immigration and health officials on arrival at Mauritius airport

Passengers travelling through hubs or making a stopover must take into consideration the COVID-19 protocols in the respective countries

## 5. Leisure



Activities including watersports, scuba diving, golf courses and fitness centres will be available

The kids' and teens' club will be open and babysitting services are available, with sanitary protocols in place

The use of the spa (excluding the hammam and sauna) is allowed

You can explore our beautiful island's landscapes and attractions, abiding by the local sanitary protocols

## 3. Arrival & transfer



You will have a temperature check on arrival via thermal camera

Wearing a face mask and sanitising hands regularly is mandatory

Antigen tests will be carried out at the hotel on arrival (day 0) and on day 5. These will be chargeable, subject to your hotel policy

After baggage collection, you can be taken to your hotel by a DMC, taxi or other means of transportation. Face masks must be worn in the vehicle

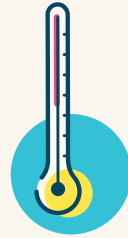

# Before departure

- Plan your holiday, staying in one of the island's hotels
  - Travellers must be fully vaccinated to enter Mauritius and meet one of the following criteria:
    - be fully vaccinated with two doses of a COVID-19 vaccine recognised by the Mauritian authorities. Mixed vaccination is accepted with proof of both doses. The second dose, if any, must have been administered at least 14 days prior to arrival;
    - have received a single dose of the Johnson & Johnson's Janssen vaccine at least 28 days before travel;
    - have an official document proving that they have already had COVID-19 with evidence of having had a jab at least 14 days before travel;
    - be a minor aged under 18 years old who is currently exempted from vaccination and travels with his/her family
  - You must take out mandatory health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)
  - All travellers must be aware of the conditions of their stay prior to departure, including the need to comply with preventive measures and undergo tests that are compulsory or required by the authorities
  - All travellers, including children and infants, must undergo a PCR test within 72 hours before their departure for Mauritius. An oropharyngeal swab can be collected in case of children up to 6 years of age. A negative PCR test result is required to be allowed to travel

# Airport and flight

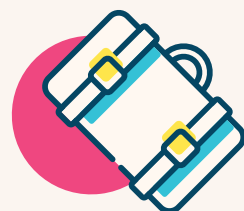
- Mandatory documents required at check-in:
  - A negative PCR test result obtained within 72 hours before departure
  - Proof you have been fully vaccinated or official documentation proving that you have already had COVID-19 and have had a jab 14 days prior to travel (28 days if you have had Johnson & Johnson's Janssen vaccine)
  - Proof of mandatory health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)
- Wear a mask covering your nose and mouth throughout the flight, unless when eating or drinking, and disinfect your hands regularly
- Fill out the health forms before or during your flight to Mauritius. These include the passenger locator form and the health self-declaration form, which you can find at [mauritiusnow.com/mauritius-travel-advice](https://mauritiusnow.com/mauritius-travel-advice). You will need to hand over these completed forms to immigration and health officials on arrival at Mauritius airport
- Passengers travelling through hubs or making a stopover must take into consideration the COVID-19 protocols in the respective countries

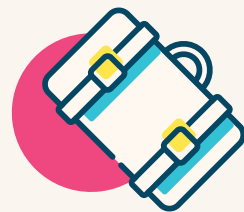
# On arrival in Mauritius

- A body temperature check will be carried out via thermal camera on arrival at the airport. Passengers whose temperature exceeds 37.8°C or showing any other visible symptoms will be isolated in a designated room. They will be examined by a doctor at the airport and a GeneXpert PCR test may be carried out; the result will be available within approximately one hour. Depending on the result, they will be directed to a treatment centre or to their hotel
- You may be asked for proof of your mandatory health insurance, covering COVID-19 treatment, on arrival
- You must sanitise your hands upon arrival at the airport
- You must wear a face mask within the airport
- Antigen tests will be carried out at the hotel on arrival (day 0) and on day 5. These will be chargeable, subject to your hotel policy

# Transfer to your hotel

- After baggage retrieval, you will be taken to your hotel by a DMC, a taxi or other means of transportation. Passengers must properly wear a face mask throughout the transfer
- You must sanitise your hands before entering the vehicle
- It is recommended that the windows are open throughout the transfer

# At the hotel

- You will be subject to an antigen test on arrival at the hotel and, depending on the length of your stay, day 5. These are chargeable, subject to hotel policy
- Nasopharyngeal swabs must be collected from adults and oropharyngeal swabs from children up to 6 years of age
- You will be asked not to walk around the hotel during the interval (15 minutes) between taking the test and the results being available
- Guests with a negative antigen test result may return to their room and be considered COVID-19 negative
- You will be required to maintain social distancing during your stay while circulating in the hotel premises. You will be able to remove your mask at the beach, at the swimming pool and when seated at a table or at the bar
- All hotel staff, as well as their immediate family, have been vaccinated
- Housekeeping in the guest rooms will be carried out in strict compliance with sanitary protocols

# Leisure

- After a negative test on day 0, you can explore our beautiful island's landscapes and attractions, abiding by the local sanitary protocols

# What if there is a suspected or confirmed case at my hotel?

- Any guest who tests positive during an antigen test will be asked to stay in isolation in a designated room until a PCR test is carried out by the Ministry of Health and Wellness and the result is obtained. Quarantine-type room service must be provided during the waiting period
- If the PCR test result is positive, the guest must be transferred to the area of the hotel used for COVID-19 positive cases. The Ministry of Health and Wellness will check whether the guest is at medical risk. The person in question must stay in isolation for 10 days without their family/travelling companions if asymptomatic
- Following an assessment of the guest's medical condition by the Ministry of Health, hospitalisation may be required. This may be a treatment centre, a public hospital or a private clinic. Repatriation is possible
- Relatives accompanying a positive guest will have to self-isolate for 7 days in the separate designated part of the hotel according to the quarantine protocols. They will have to undergo a PCR test after the 7-day period. In the event of a negative test result, they will be allowed to move freely around the hotel
- If the positive guest is a minor under the age of 15 or a dependent person, he/she may be accompanied in isolation by another person. However, such person must be informed that he/she must remain in isolation for at least 7 additional days after the day on which the infected person is considered infection-free
- If after the initial 3-day period, the person who tested positive for COVID-19 is symptomatic, 3 more days must be added to the self-isolation period and after the symptoms have disappeared

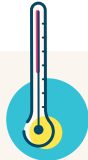

# Your journey to Mauritius

Fully vaccinated travellers can explore Mauritius from 1 October 2021 onwards

## 1. Pre-departure



Plan your holiday, staying in one of the island's self-catered villas, bungalows, guest houses, B&Bs or your home if you are a Mauritian resident

Ensure you are fully vaccinated (unvaccinated guests must book a quarantine stay)

Children are exempted from vaccination if under 18 years of age and travelling with their family

To enter Mauritius, you must present a negative PCR test taken within 72 hours before departure

Book mandatory health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)

## 4. At your accommodation



Relax in your accommodation or at your home on the island

Depending on the length of your stay, you will also be required to do a self-administered antigen test on day 5. This can be purchased from a pharmacy on the island or bought in advance and taken with you

If you test positive for COVID-19 and are asymptomatic, you will have to isolate for seven days within your accommodation. Your family/travelling companions must also self-isolate

- A negative PCR test result obtained within 72 hours before departure

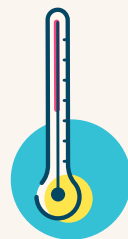

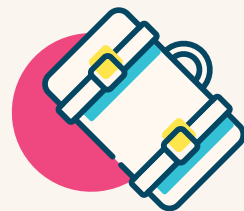

# On arrival in Mauritius

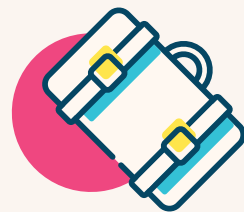
- You will be required to take a free PCR test on arrival at the airport (day 0). The Ministry of Health and Wellness will call you with your result within 6-12 hours
- A body temperature check will be carried out via thermal camera on arrival at the airport. Passengers whose temperature exceeds 37.8°C or showing any other visible symptoms will be isolated in a designated room. They will be examined by a doctor at the airport and will be directed to a treatment centre or to their accommodation
- You may be asked for proof of your mandatory health insurance, covering COVID-19 treatment, on arrival
- Hand sanitisation is mandatory upon arrival at the airport
- You must wear a face mask within the airport

# Transfer to your accommodation

- After baggage retrieval, you will be taken to your accommodation by a DMC, a taxi or other means of transportation. Passengers must correctly wear a face mask throughout the transfer
- You must sanitise your hands before entering and getting out of the vehicle
- It is recommended that the windows are kept open throughout the transfer

# At your accommodation

- You can relax in your accommodation or at your home on the island
- Wait for the Ministry of Health and Wellness to inform you of your day 0 PCR test result. This should happen within 6-12 hours. After a negative test result, you can freely explore Mauritius
- Depending on the length of your stay, you will also be required to do a self-administered antigen test on day 5. This can be bought from a pharmacy on the island or bought in advance of your holiday and taken with you
- The Ministry of Health will carry out random checks to ensure you have carried out your day 5 antigen test

# What happens if I test positive during my holiday?

- If you test positive for COVID-19 on your day 0 PCR test, you will be contacted by the authorities by phone within 6-12 hours
- If you test positive for COVID-19 and are asymptomatic, you will have to isolate for 10 days within your accommodation
- If the COVID-19 positive person shows worrying clinical symptoms, he/she must call the Ministry of Health and Wellness on 8924 to be assessed. The positive person may be hospitalised in a public or private healthcare facility of his/her choice
- Your travelling companions must also isolate for seven days

- To enter Mauritius, you must present a negative PCR test taken within 72 hours before departure
- You must book a 14-day quarantine stay, including meals and transfers
- You will be required to stay in your hotel room for 14 nights
- You will have a PCR test on arrival, day 7 and day 14. The cost for all three PCR tests will be Rs 12,000
- After a negative PCR test on day 14, you can freely explore the island and move to other accommodation or go home

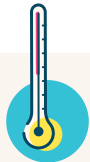

# Your journey to Mauritius

Unvaccinated guests must book a 14-night quarantine stay in an official quarantine hotel

## 1. Pre-departure



Book a quarantine stay in one of our approved hotels, which includes meals and transfers. You can find a list of quarantine hotels at [mauritiusnow.com/where-to-stay-in-mauritius](https://mauritiusnow.com/where-to-stay-in-mauritius)

To enter Mauritius, you must present a negative PCR test taken within 72 hours before departure

Book mandatory health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)

## 4. At your quarantine hotel



You will need to stay in your hotel room for 14 nights and meals will be delivered to your room

You will have a PCR test on your day of arrival at the airport, day 7 and day 14

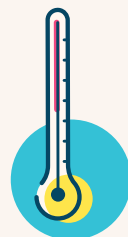

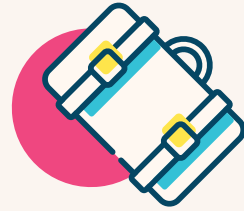

  - Proof of health insurance covering COVID-19 treatment (Mauritian nationals and occupation/residence permit holders are exempted)
- Wear a mask covering your nose and mouth throughout the flight, unless when eating or drinking, and disinfect your hands regularly
- Fill out the health forms before or during your flight to Mauritius. These include the passenger locator form, health self-declaration form and health laboratory form, which you can find at [mauritiusnow.com/mauritius-travel-advice](https://mauritiusnow.com/mauritius-travel-advice). You will need to hand these completed forms to immigration and health officials on arrival at Mauritius airport
- Passengers travelling through hubs or making a stopover must take into consideration the COVID-19 protocols in the respective countries

# On arrival in Mauritius

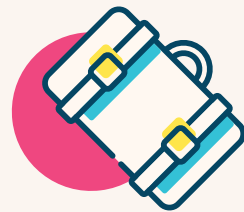
- You will be required to take a PCR test on arrival at the airport (day 0). You will also be required to take a PCR test on day 7 and day 14 of your quarantine stay. The cost is Rs 12,000 for all three tests
- A body temperature check will be carried out via thermal camera on arrival at the airport. Passengers whose temperature exceeds 37.8°C or showing any other visible symptoms will be isolated in a designated room. They will be examined by a doctor at the airport and either directed to a treatment centre or to their quarantine hotel
- You may be asked for proof of your health insurance, covering COVID-19 treatment, on arrival
- Hand sanitisation is mandatory upon arrival at the airport
- You must wear a face mask within the airport

# Transfer to your quarantine hotel

- After baggage retrieval, you will be taken to your quarantine hotel by a DMC. Passengers must properly wear a face mask throughout the transfer
- You must sanitise your hands before entering the vehicle
- It is recommended that the windows are kept open throughout the transfer

# At your quarantine hotel

- You will need to stay in your hotel room for 14 nights and meals will be delivered to your room
- You will be required to take a PCR test on day 0 (at the airport), day 7 and day 14 of your quarantine stay. The cost is Rs 12,000 for all three tests
- After a negative PCR test on day 14, you can freely explore the island and move to new accommodation or to your home

# Returning to the airport


- If you need to depart Mauritius early and require an additional PCR test, this will be at an extra cost between Rs 2500 - 3500

# What happens if I test positive during my quarantine stay?

- If you test positive during your quarantine stay and are asymptomatic, your 14-day quarantine period will remain the same
- Following an assessment of the guest's medical condition by the Ministry of Health and Wellness, hospitalisation may be required. This may be a treatment centre, a public hospital or a private clinic. Repatriation is possible
