
PUBLICATION OF WANDERNEST TIERED COUNTRY LIST AND BLOG ROLLOUT SCHEDULE

I write on behalf of Team WanderNest to provide a formal notice regarding two related items enclosed with this correspondence: our curated Tiered Country List and the official blog publication schedule. For ease of reference, the complete Tiered Country List (countries grouped by Tier 1 → Tier 4) is presented on page 2 of the attached document.

Key information is summarised below:

1. Location of the Tiered Country List

The full list of countries, arranged by tier for editorial and planning purposes, appears on page 2 of the attachment. The list is an internal editorial tool intended to help prioritise content and resources across our platform.

2. Blog Publication Start Date

WanderNest will commence publishing the tiered blog series on 9 September 2025. This initial publication marks the launch of our coordinated content rollout.

3. Publication Flow and Order

The blog rollout will proceed sequentially from Tier 1 through Tier 4. In other words, content relating to Tier 1 (Major Global Destinations) will be published first, followed by Tier 2 (Strong but Secondary), then Tier 3 (Emerging), and concluding with Tier 4 (Remote / Least Visited / Crisis-affected) destinations. This phased approach ensures a consistent editorial flow and allows us to prioritise resources and quality control at each stage.

4. Purpose and Use

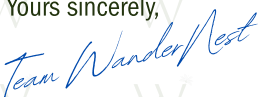
