Eligibility & Prerequisites

Identification, AKTR, and Medical

- ☐ Please verify that the names on the ID, pilot certificate, medical, and knowledge test results are full legal names and match exactly. Notify examiner of any discrepancies.

IACRA

- ☐ Complete the 8710.1 and ensure it is signed by recommending CFI:
(Requires recommending CFI gave training)
- ☐ Confirm all time listed in the Aeronautical Experience match the applicant's logbook
 - o Total Time should be more than dual time plus solo time unless all prior practical tests were conducted under 141 examining authority and the applicant has only conducted training flights (no rentals)
- ☐ Ensure that the class rating times are completed properly

The **data on my medical** does not match what is in the FAA Airman Registry database, what should I do?

If it is less than 60 days since the date of issue of your certificate, contact your AME (Aeromedical Examiner) for resolution of this issue. If it is 60 days or more from the date of issue of your certificate, contact the FAA Aerospace Medical Certification Division for resolution of this issue. - ☐ No logbook entries marked as solo and dual unless when added together = flight total time
- ☐ No Simulated Instrument on solo entries
- ☐ Check for math errors
