President's Column Tony Spakauskas, President DPPOA Board of Directors



Greetings all,

The first thought that came to mind when I sat down to write was, "Snow is a four-letter word." This winter season saw three significant snowstorms, the worst occurring the first week of January. Two additional, less severe, snows occurred in February. While there were apparently some areas that were missed by the salt and plow trucks, these issues were resolved as quickly as possible, and Rhea met with the contractor to review any problem areas so that these mistakes do not happen again. A number of community e-mails were sent in order to keep everyone aware of plans for treatment with salt and plowing when necessary. We are hopeful that spring is upon us and the snow season is behind us.

The cost to treat and remove the snow totaled \$93,837. This includes an increase in the cost of salt from previous years, from \$229/ton to \$260/ton. Treating the entire community requires 20 tons of salt. The Special Tax District funded \$60,738 of the cost, with the balance paid from Covenant fees. While trying to be as judicious as possible when calling in the snow removal contractor, we still went over the budgeted amount of \$45,000, the usual amount allocated.

In addition to the higher than usual cost of snow removal, the Association saw an increase in the cost of insurance coverage. Nationwide Insurance Company increased its annual premium from \$6,471 to more than \$16,000. Our agent sought out other companies and could not find one that offered a lower premium, and many are now unwilling to offer coverage to associations adjacent to water. We finally spoke with an agent who represents State Farm and were offered a premium of \$11,186, which we accepted.

Given the increased cost of snow removal as well as the rising cost of insurance, the Board may have to consider an increase in the mandatory assessment for Fiscal Year 2027, which begins July 1, 2026. Many of you have already paid fees for Fiscal Year 2026, which begins July 1, 2025 (we bill ahead of each fiscal year as required by the Covenants). The Mandatory Assessment of \$55.00 on a developed property and \$20.00 on an undeveloped property has not changed since it was first assessed in 2014, and this would be the fee that may be increased. The Board will discuss all options but does have a responsibility to see that the community is well maintained.

With spring nearly upon us, I wish all of you happy, warm days to come.

Nominating Committee and Slate of Candidates

The job of the Nominating Committee is to speak with community–minded property owners who may be interested in serving on the Board of Directors for the upcoming term, which begins in July. If you are interested in serving, please contact the Association office. There are currently three open seats and three candidates, but all interested parties can be added to the slate.

Association By-laws require that the Slate of Candidates for the upcoming year be presented by the Nominating Committee at the March meeting of the General Membership, and nominations can be made from the floor at that time (anyone nominated during the meeting will have their name added to the Slate of Candidates to be presented). However, if the number of open seats remains equal to the number of candidates, a motion can be made to elect the slate by acclamation, and this does save the cost and time it takes to process and mail a ballot.

If there is no quorum, the business of the Association cannot be conducted, and the Slate of Candidates cannot be presented. A quorum requires 35 memberships be represented. A married couple represents one membership unless each of them is the sole owner of a separate lot. An **absentee ballot**, to accept the slate of candidates, as presented at the meeting and approve should there be no nominations from the floor, will be available in the DPPOA office. **Absentee ballots** count toward a quorum. Pick one up if you are unable to attend. If a quorum is not present, it will be necessary to hold a special meeting in April, so encourage your friends and neighbors to attend or pick up the **absentee ballot**.

Spring Cleanup

The community cleanup will be scheduled in the coming weeks (watch your email for the date). The dumpsters will be available to all Drum Point residents from 8:00 a.m. until 2:00 p.m. Please do not leave items before 8:00. Someone will be along shortly to help direct which items go into which bin.

For those of you who may be unfamiliar with the community cleanup, dumpsters are placed on the vacant lot across from the DPPOA office at 401 Lake Drive. Owners and residents can bring their unwanted items to the dumpsters. One dumpster will be set aside for the recycling of metal, at no cost to the Association. The Association is charged a fee for the dumpster used for disposal of all other items.

This is your opportunity to recycle that old grill and anything else made primarily of metal as well as clean out the winter's accumulation of unwanted items. Please note below those things which CAN and CANNOT be accepted:

Items which CAN be accepted include:

- Stoves and Grills
- Lawn mowers, Weed eaters etc.
- Furniture
- Exercise Equipment
- Metal for recycling

Items which CANNOT be accepted include:

- Household trash/garbage
- Building material
- Tires Batteries
- Tree branches and other yard debris
- Paints, stains and other hazardous material
- Televisions and computer monitors
- Refrigerators and AC units.
