Time for Winter Already?

We can expect that we will have sufficient snow this season which will require plowing. In past years, we have had complaints about the snow plow pushing snow into a driveway that has been shoveled out. Some of these complaints come from people who live on dead-end streets or cul-de-sacs. Others come from owners who have driveways that are perpendicular to the street road surface. In both cases, our snow plow operators make every effort to be as kind as possible in the placement of snow.

For driveways off of streets, it is not possible to keep snow from accumulating at driveway entrances as the roadway is plowed, we simply do not have the money or the time to open up each driveway entrance as the snow plow passes.

For dead end streets and cul-de-sacs, the operators have to determine where to put the snow at the end of their plowing run. Sometimes, especially when plowing at 3:00 a.m., it is difficult to determine where a driveway enters the cul-de-sac or where the road actually dead ends. In these cases we will make every effort to not block anyone in.

Drum Point Property Owners Association does not budget for or pay for the plowing of driveways. The driveway and the entrance to it are the responsibility of each homeowner.

We appreciate your understanding. Please call the office if a problem arises.

If you walk your dog in Drum Point, please remember to clean up after your pet. It's not only the considerate thing to do, there's a County ordinance which states that a person may allow their dog to defecate on common areas of a community, but the feces must be "immediately removed by a sanitary method and disposed of in an appropriate trash receptacle." (§7-6 702 B-3)

For those of you unfamiliar with the community cleanup, dumpsters are placed on the vacant lot across from the DPPOA office at 401 Lake Drive. Residents, who wish to, can bring their unwanted items to the dumpsters.

One dumpster will be set aside for the recycling of metal. This is your opportunity to get rid of that old grill and anything else made primarily of metal.

Items which can be accepted include:

- Stoves
- Grills
- Lawn mowers, weed eaters etc.
- Furniture
- Exercise Equipment
- Metal for recycling

Items which cannot be accepted include:

- Household trash/garbage
- Building material
- Tires
- Batteries
- Tree branches and other yard debris
- Paints, stains and other hazardous material
- Televisions and computer monitors
- Refrigerators and AC units.
