Community Beach Rules

The Drum Point Community Beach is open to all property owners, residents and their guests. The gate is opened and closed during the summer months by a group of dedicated volunteers. During summer weekends, another group checks to be sure that anyone trying to enter the beach comes under one of the categories listed above. These people are paid for their time as it is not an easy task.

On occasion, there has been a bit of confusion with regard to the rules of the Community Beach, which are posted on a large sign sitting to the right of the gate as you enter the beach. The rules have also been posted to the website, at the suggestion of a resident (a good idea not previously considered).

The rules that are in place are there in large part due to the fact that the Community Beach is quite small in comparison to the area owned by the Drum Point Club to the south. FALL CLEANUP

The community cleanup has been scheduled for Saturday morning, September 28, 2019, and the dumpsters will be available to all Drum Point residents from 8:00 a.m. until 2:00 p.m.

For those of you who may be unfamiliar with the community cleanup, dumpsters are placed on the vacant lot across from the DPPOA office at 401 Lake Drive. Owners and residents can bring their unwanted items to the dumpsters.

One dumpster will be set aside for the recycling of metal, at no cost to the Association. The Association is charged a fee for the dumpster used for disposal of all other items.

This is your opportunity to recycle that old grill and anything else made primarily of metal as well as clean out the inevitable accumulation of unwanted items.

Please note the list of items, established by Calvert County, which **CAN and CANNOT** be accepted:

Items which <u>CAN</u> be accepted include:

- Stoves
- Grills
- Lawn mowers, weed eaters etc.
- Furniture
- Exercise Equipment
- Metal for recycling

Items which CANNOT be accepted include:

- Household trash/garbage
- Building material
- Tires
- Batteries
- Tree branches and other yard debris
- Paints, stains and other hazardous material
- Televisions and computer monitors
- Refrigerators and AC units.





FALL PAVING

Oh it's paving time again, we have to tell you (sing that to "Crying Time" by Ray Charles).

Many of you may have noticed the white marks on the pavement and even on your driveways. These are marks to show our pavers where to mill in preparation for the re-pavement this year. These marks have been down for a while because we had to measure for the amount of asphalt and give visual guidelines for those paving contractors that bid on the work.

The bidding and award process is now complete and we are planning to start and complete the work in September of this year. Of course, paving is weather dependent, so we cannot give a specific date, or guarantee that it will not slide into October, but the plan is for the work to be done in September. Great Mills Trading Post was awarded the contract during the August Board meeting.

As with all paving every year, the contractors will help guide you around paving operations and will [in most cases] pave half of the street at a time so that you can pass. BUT, if you need to drive on the new asphalt, PLEASE drive slowly and make smooth turns. This will help keep the new asphalt from being marred or damaged.

Here are the streets that will be affected:

- Bay View Drive
- Lake View Drive (southwest from Bay View Drive)
- Calvert Terrace
- Dove Court
- Blue Jay Drive
- Lake Lane
- Laurel Way (from Lake Drive ending at Bay View Drive)
- Dogwood Drive (from Laurel Way, east to Lake Drive)
