#### **Speeding and Speed Limits**

The meeting of the general membership that took place in September was well attended, with a number of issues discussed.

One of the primary points of concern involved the number of people who continue to drive too fast for a neighborhood community such as Drum Point.

In response to the concerns voiced during the meeting, a letter was sent the following day to Sheriff Evans, who will remain in office until the end of the year. The letter included questions about speed limits in Drum Point and whether patrols can be increased in the community. Sheriff Evans was invited to attend the next meeting of the membership, scheduled for December. We await his response.

Sergeant Jason Dean, a community liaison officer, did reply to an email sent a few days later and responded as follows to some of the questions posed:

- Issuing tickets: "If there is a validated speeding issue within the jurisdiction of our responsibility, we will respond appropriately. This response could be in the form of focused enforcement, educational outreach initiatives to curve speeding behaviors or as simple as increasing our visible patrols within the area."
- Lower posted speed limits: "The State regulated that posted maximum speed limits within undivided highways in residential districts cannot exceed 30 mph. The posted speed limit has been set to 25 mph as a standard within most communities. This is based on crash data to include pedestrian strike survival testing and safety, roadway design and the volume of traffic within the respective area. There would need to be a documented substantial safety concern for the speed limit to be reduced below 25 mph. To the best of my knowledge, the risk of pedestrian fatalities or serious injury crashes within Drum Point is not significant. In order to consider a reduction in speed limit, a traffic and engineering investigation would be completed to establish a reasonable and safe speed limit based on serious or significant crash event history. We thankfully do not have a significant crash event history within Drum Point, so my opinion is that we cannot justify a speed limit reduction request and/or study. "

Sergeant Dean stated also that a deputy can attend the next membership meeting, which is scheduled for December 17th at 10:00 a.m. This is

#### The Environmental Corner

The annual Phragmites treatment was done at the end of October. While the usual spots were treated, an area at the end of the Drum Point boat ramp on River View Drive was also included in this year's list.

With the continued success of the program, the cost has been reduced from an initial outlay of \$985.00 in 2017 to this year's fee of just \$500. The program has been so successful that we may be able to skip next year's treatment. In addition, natural vegetation has begun to grow in the treated areas.

With cooler weather upon us, and therefore, a reduction in the risk of encountering ticks, the Ivy League will continue its mission of the elimination of as much ivy as possible from the trees. While the ivy can be beautiful, it can choke out native plants and can kill a tree if allowed to grow unchecked.

The group met on Saturday, November 12th and cleared the ivy from a tree on a lot at the corner of Barreda Boulevard and Oak Drive.
