- 1. Meeting opening

 - 297 carp removed, estimated weight ~2,000 lbs.
 - Enviroscience compiling data from "carp event" ended up taking place over two (2) nights due to boat mechanical malfunction on the 1st night
 - What has been learned, will be used to improve "cost per carp removed" metric
 - Target dusk (more yield, activity)
 - Current water temp 65 degrees
 - Area where there is less wind, wave action and/or boat traffic provided higher yield
 - Enviroscience sediment testing (study) confirmed 13'-14' of sediment in middle of the lake. Study will continue during next scheduled event – Weds, May 23rd
 - Jeff/John confirmed expenses, to date, are within budget
 - May 23, 2018
 - Next scheduled day for carp removal
 - Conduct turbidity study
 - Continue sediment testing
 - Board discussed options to dispose of carp captured during the May 23rd event
 - Dig hole and cover with soil concerns raised around potential smell and infiltration of predatory animals

- Rent/pay for another dumpster
- John made a motion to move forward with securing a dumpster. Rick seconded the motion. Issue was put to vote: All in favor, non-opposed
- Jerry suggested we gain a better understanding of what it would take to obtain more info/clarity on what it would take and impacts of "burying the carp" next year
- 3. Signage update by Rick
 - One (1) pole without a sign located just off the shoreline on the back road which needs removed
 - *Update: Pole removed from lake on Weds, May 23rd
- 4. Buoys update by John and Jeff
 - John confirmed receipt of eight (8) new buoys. Eight (8) Buckets filled with cement, an "I-bolt" and chains have been prepped
 - Jeff confirmed the "ski-club" will install buoys Saturday, May 19th
- 5. Lake Safety Patrol update by Jerry, John and Joe Tuscano
 - Welcomed current Lake Safety Patrol" Joe Tuscano
 - Joe shared his recent observations:
 - There are a few trees which have fallen around the lake shoreline
 - There are a few boats on the water which do not have an ALA sticker
 - Joe confirmed he will...

 - Use a tape recorder versus writing activity down. This will enable him to quickly and accurately capture event(s) then allow him time to compile his notes into written form/log

- John confirmed he maintains a master log of all boats on Aurora Lake
- John is ok that Joe will send only the Aurora Shores boat observations/rules violation(s) to Aurora Shores ALA representative, however, he requested that Joe send both Aurora Shores and Hawthorne observations/rules violation(s) to him
