1. Patrol Boat

- d. Pontoons were drained, John will investigate the damage and will determine cost of repair from D&D
- e. Decision will be made in the offseason to sell and purchase a new patrol boat, or to invest and upgrade the pontoon boat to look more like a patrol boat

2. Bathymetry Study
