The Ziebach County Commissioners met in regular session at 1:00 PM with Rick Farlee, Bill Henderson, Shane Farlee, Tucker Stocklin, Shane Farlee and David Pesicka present. Chairman R. Farlee called the meeting to order.

Minutes: Comm. Stocklin moved to approve the minutes as presented, seconded by Comm. S. Farlee, all voted aye, motion carried.

Hwy Dept. Report: Jeff Jensen, Highway Superintendent, sent his report to the commission as he was sick and was unable to attend. The report updated the Commissioners on progress on the roads.

Sheriff's Report: Gary Cudmore, Sheriff was currently out of the office. No report was given.

FUEL QUOTES: The Highway Department called for quotes for #2 dyed diesel (2,000 Gal.) on September 17, 2024. The following quotes were received: Agtegra - #2 Dyed DSL, \$2.68; Farmers Union Oil - #2 Dyed DSL, \$2.73. The quote from Agtegra was accepted.
