ZIEBACH COUNTY COMMISSIONERS

FEBRUARY 8, 2023

The Ziebach County Commissioners met in regular session at 9:00 AM with Shane Farlee, Bill Henderson, David Pesicka, Rick Farlee and Tucker Stocklin present. Chairman R. Farlee called the meeting to order.

MINUTES: Comm. Pesicka moved to approve the December 29, 2022, January 3 & 20, 2023 minutes as presented, seconded by Comm. S. Farlee, all voted aye, motion carried.

SB 150: The Board discussed SB 150 regarding livestock pipelines on highways as introduced. No action was taken.

BUDGET SUPPLEMENT: Comm. Henderson moved to acknowledge receipt of \$3264.80 from the National Opioid Settlement and to supplement the budget as follows, seconded by Comm. Stocklin, all voted aye, motion carried:

GENERAL FUND – PUBLIC SAFETY – SHERIFF \$3264.80

BUDGET SUPPLEMENT: Comm. S. Farlee moved to supplement the following budget with LATCF funds, seconded by Comm. Henderson, all voted aye, motion carried:

GENERAL FUND – TECHNOLOGY \$25,000.00

OPERATING CASH TRANSFER: Comm. Stocklin moved to transfer \$17,760.00 from the General Fund to the Emergency Management Fund as budgeted, seconded by Comm. S. Farlee, all voted aye, motion carried. **SHERIFF REPORTS:** Gary Cudmore, Sheriff presented his monthly vehicle reports to the Board.

SNOW PLOWING: At 9:30 AM, the Board met with Melissa Maher and Kent Larson from Moreau-Grand Electric; Dakota Longbrake of the CRST Department of Transportation; and John Kessler and Buddy Knife, CRST Council Members, to discuss emergency snow plowing protocol during blizzard conditions. After a lengthy discussion, it was agreed that there should be a single point of contact in these situations, possibly the Emergency Manager once the position is filled. Dakota Longbrake, CRST Transportation Department and Jeff Jensen, Ziebach County Highway Superintendent will meet to discuss a cooperative plan for snow removal in the future.

EMERGENCY MANGEMENT: Shane Farlee and Tucker Stocklin presented information from the recent meeting with Dewey County on the possibility of combining the Emergency Manager position for Ziebach and Dewey Counties. John Kessler, CRST Council Member also informed the Board that they were looking for an Emergency Manager. Ziebach County will keep the discussion open with Dewey County and also check to see if there are any other counties that share an Emergency Manager.

ROAD SAFETY PROJECT: Dakota Longbrake informed the Board that the Cheyenne River-Ziebach County Route 55 Realignment Safety Project has been awarded in the amount of \$1,287,876.27. Further details for the project will be provided soon.

GAS QUOTES: The following gas quotes were received: Dupree Oil LLC – E-10 Gas, \$3.09. Farmers Union Oil Co. – SNL Gas, \$3.119. Comm. Stocklin moved to accept the quote from Dupree Oil LLC, seconded by Comm. Pesicka, all voted aye, motion carried.

WEIGHT LIMITS & SPEED LIMIT ENFORCEMENT: The following resolution is still in effect with no changes being made:

ZIEBACH COUNTY SPEED LIMITS & WEIGHT PER AXLE LIMITS

WHEREAS, the County of Ziebach, South Dakota, is responsible for the maintenance of certain highways under its jurisdiction, and

WHEREAS, Ziebach County desires to protect existing Ziebach County roads, ultimately saving tax dollars, and

WHEREAS, Ziebach County desires the enforcement of weight limitations and speed limits on Ziebach County roads as set forth and posted by the Ziebach County Highway Superintendent.

NOW THEREFORE BE IT RESOLOVED, that the limits on Ziebach County roads shall be set at six (6) ton per axle with an 80,000 GVW, on all county roads when limit signs are in place.

IT IS FURTHER RESOLVED, that the County of Ziebach shall request the South Dakota Highway Patrol Motor Carrier Enforcement Officers to enter the County of Ziebach with scales adequate to weigh motor vehicles to ensure compliance with State Laws pertaining to vehicle weight, and with the weight laws established by this Resolution.

NOW, THEREFORE, BE IT RESOLVED, that the speed limit on all county roads within Ziebach County, South Dakota shall be 55 MPH, unless posted otherwise. Ziebach County requests the South Dakota Highway Patrol to enter the County of Ziebach to enforce the speed limit on all Ziebach County roads.

IT IS FURTHER RESOLVED, that this resolution be effective each and every year hereafter unless repealed or modified by duly enacted resolution.

BANK FRANCHISE: Ziebach County received \$161,925.77 in Bank Franchise funds for 2023. The County's share of these funds is \$56,493.76. This is a significant increase from last year.

2022 ANNUAL REPORT REVIEW: The Auditor reviewed the 2022 Annual Report with the Board. The report will be filed with Legislative Audit and published.
