JUNE 7, 2023

The Ziebach County Commissioners met in regular session at 9:00 AM with Bill Henderson, Shane Farlee and Tucker Stocklin present; Rick Farlee and David Pesicka absent. Vice-Chairman Henderson called the meeting to order.

MINUTES: Comm. S. Farlee moved to approve the minutes as presented, seconded by Comm. Stocklin, all voted aye, motion carried.

HWY. DEPT. REPORT: Casey Gage, Highway Superintendent presented his written report and reported to the Board on CDLs, gravel hauling, truck repairs and road maintenance. Casey requested permission to buy a tiller to help with road maintenance. He will get a quote and present it at the next meeting.

DIESEL QUOTES: The Highway Department called for quotes for #2 dyed diesel on May 30, 2023. The following quotes were received: Dupree Oil LLC - #2 Dyed DSL, \$2.98; Farmers Union Oil - #2 Dyed DSL, \$3.09. The quote from Dupree Oil LLC was accepted.

4-H ADVISOR/PART-TIME ASSESSOR: Doug Hofer began summer employment on June 5, 2023, as 4-H Advisor/Part-time Assessor, at \$17.95 per hour.

STBGP: Ziebach County received \$240,475.28 from the Surface Transportation Block Grant Program for 2023.

AUDITOR POSITION: The position of Auditor is still open as there have been no applications thus far. Comm. Stocklin move to pay Cindy Longbrake \$32.00 per hour plus mileage to assist occasionally with office work when requested and to train the new auditor when hired. Seconded by Comm. S. Farlee, all voted aye, motion carried.

SHERIFF’S REPORTS: Gary Cudmore, Sheriff presented his monthly vehicle reports to the Board and commented on recent law enforcement activities.

CO2 PIPELINE: Jana Hunt presented information on her concerns regarding private property rights currently being threatened by illegal use of eminent domain by Summit Carbon Solutions and Navigator CO2 pipelines in Eastern South Dakota. She requested Ziebach County send a letter in opposition to the CO2 pipelines to the SD PUC. This will be added to the July agenda to be considered when a full quorum is present.

GAS QUOTES: The following quotes for gas were received: Dupree Oil LLC – E-10 Gas, \$3.16; Farmers Union Oil Co. – SNL Gas, \$3.15; NL Gas, \$3.50. Comm. Stocklin moved to accept the quotes from Farmers Union Oil Co., seconded by Comm. S. Farlee, all voted aye, motion carried.

TEMPORARY LIQUOR LICENSES: At 10:30 AM, the Board considered the application for a temporary malt beverage license and a special event on-sale liquor license for the Dupree Pioneer Days Rodeo Committee for June 23, 24, & 25, 2023. As no one appeared in opposition thereto and the appropriate fee being received, Comm. Stocklin moved to approve the licenses, seconded by Comm. S. Farlee, all voted aye, motion carried. This license is good from midnight to midnight on the days specified.

2024 BUDGET: The Auditor asked the Board for any changes or updates that might need to be added to the 2024 Budget. All department budgets will be reviewed at the next meeting.

SIDEWALK RELACEMENT: Estimates for the sidewalk replacement requested by EMC insurance will be presented at the July meeting.
