## NOVEMBER 10, 2022

The Ziebach County Commissioners met in regular session at 9:00 AM with Clinton Farlee, Bill

Henderson, David Pesicka, Rick Farlee and Ralph Lyon present. Chairman C. Farlee called the meeting to order.

**MINUTES:** Comm. R. Farlee moved to approve the October minutes as presented, seconded by Comm. Pesicka, all voted aye, motion carried.

**FUEL QUOTES:** The Highway Department called for fuel quotes on November 3, 2022. The following quotes were received: Farmers Union Oil Co. – NL Gas, \$3.859; SNL Gas, \$3.119; Dyed #2 DSL, \$4.269; Dyed #1 DSL, \$4.769; Clear #2 DSL, \$4.779. All Prices good through November 15, 2022. The quotes from Farmers Union Oil Co. were accepted through November 15, 2022.

**WATER PIPELINE EASEMENT:** Comm. Lyon moved to approve the Easement to Install Water Pipeline for Rod Hoffman, seconded by Comm. Henderson, all voted aye, motion carried.

**HWY. DEPT. REPORT:** Jeff Jensen, Highway Superintendent presented his monthly written report to the Board. Also discussed was gravel hauling and the removal of cars and other debris from Ziebach County roads and ditches.

**GENERAL ELECTION CANVASS:** The Board canvassed the votes from the 2022 General Election held in Ziebach County on November 8, 2022. No errors or changes were found. Comm. Henderson moved to certify the canvass as reported, seconded by Comm. Pesicka, all voted aye, motion carried. The Board signed the Official Certificate of Canvass and it was forwarded to the Secretary of State's Office for the official state canvass.

**HEALTH INSURANCE RENEWAL:** The Board reviewed the various options for health insurance for 2023. Comm. Pesicka moved to accept the Wellmark Blue Cross Blue Shield CompleteBlue plan with a \$3500 deductible (same plan as last year), seconded by Comm. Lyon, all voted aye, motion carried. There is a 9.42% increase with the health insurance renewal plan effective December 1, 2022.

**VISION & DENTAL INSURANCE:** The Board compared our present vision and dental insurance with the Principal to the BEAM policy presented by Risty Insurance. Comm. Pesicka moved to offer the vision and dental insurance through BEAM, seconded by Comm. Lyon, all voted aye, motion carried. BEAM offers considerably lower premiums than our present insurance.

**ASSESSOR:** Misty Williams, Assessor has passed all the required courses and will move to \$44,400 annually effective October 1, 2022.

**DEPUTY TREASURER:** Tasha Tibbs, Deputy Treasurer has completed her probation period and will receive \$18.00 per hour effective with the October pay period.

**CUSTODIAN:** Dean Little Hawk, Custodian has completed his probation period and will receive \$18.00 per hour effective with the October pay period.

**LATCF:** Ziebach County received \$50,000.00 from the Local Assistance and Tribal Consistency Fund. These funds can be used for any governmental purpose other than lobbying. Comm. Lyon moved to give all county employees a \$1000.00 bonus with the November payroll and to put the remaining money towards a semi-truck for the Highway Department. Seconded by Comm. Pesicka, all voted aye, motion carried.

**OPERATING TRANSFER:** Comm. Henderson moved to transfer \$161,200 as budgeted from the General Fund to the County Road & Bridge Fund, seconded by Comm. Lyon, all voted aye, motion carried.

**HOLIDAYS:** The Board confirmed the following additional holidays granted by Governor Noem: Thanksgiving, Friday, November 25<sup>th</sup> and Christmas, Friday, December 23<sup>rd</sup>.
