October 4, 2023

The Ziebach County Commissioners met in regular session at 9:00 AM with Rick Farlee, Bill Henderson, David Pesicka, Shane Farlee, and Tucker Stocklin present. Vice Chairman Bill Henderson called the meeting to order.

Minutes: Comm. Dave Pesicka moved to approve the minutes as presented, seconded by Comm. S. Farlee, all voted aye, motion carried.

Hwy Dept. Report: Casey Gage, Highway Superintendent, brought his report before the commission. He mentioned that their current goal is to get the ditches mowed before winter to prevent snow from piling up in the ditches throughout the winter. He also informed the commissioner's about purchasing a mulcher for \$48,260. A decision will be made on this in the next meeting.

Sheriff's Report: Gary Cudmore, Sheriff presented his monthly report to the Board, commented on recent law enforcement activities. The Sheriff's department is going to use the 511 program with the DOT to better inform the community of road closures.

5-YEAR HWY. PLAN: At 10:00 AM, the proposed 5-Year County Highway and Bridge Improvement Transportation Plan for 2024-2028 was presented. The Board expressed their agreement with the plan.

There were no written comments submitted. Comm. S. Farlee moved to approve the updated 2024-2028 Ziebach County 5 – year Highway and Bridge Improvement Plan, seconded by Comm. Stocklin, all voted aye, motion carried.

Gas Quotes: Quotes received for the month of October for gas were from Farmers Union Oil Co. -SNL \$3.05; NL, \$3.55 Agtegra -SNL \$3.295. Comm. Stocklin moved to accept the quotes from Farmers Union Oil Co., seconded by Comm. Pesicka, all aye, motion carried.

New Business: Phoebe Lemke came to inform the commissioners about a nurse coming to the courthouse once a month. The nurse will be in on October 31st from 10:00 – 2:00. If you would like to schedule flu shots, you can schedule through Phoebe.

Ohti Kaga Tax Deed Process: Jessica Donovan and Misty Williams informed the Commissioners on the Tax Deed Process for Ohit Kaga. More information will be presented at the next meeting.

Credit Card Policy Updates: The commissioners were presented with updates to the credit card policy to set more parameters, as there have been no updates since 2010. The updates allow hotel rooms to be booked when direct billing is not available. As well as to allow supplies to be ordered online, when our current vendors do not have the available product. Comm. Stocklin moved to accept the new policy. Seconded by Comm. S. Farlee, all voted aye, motion carried.

Dakota Longbrake Road Grants: Dakota Longbrake came and discussed grants that the county would be eligible for. The Commissioners agreed to move forward in applying for the TTP Grant which would repair the Iron Lightening Bridge. They also discussed grants they could apply for that would improve the road by the rodeo grounds. Some Tribal Council Men were in attendance to discuss the possibility of working together to apply for the Raise grant which would allow the road to Cherry Creek to be paved. The

county agreed to move forward in applying for this grant, as well as to apply for design grants to alleviate the application costs.
