The Ziebach County Commissioners met in regular session at 1:00 PM with Bill Henderson, David Pesicka, Rick Farlee, Shane Farlee and Tucker Stocklin present. Chairman R. Farlee called the meeting to order.

MINUTES: Comm. Dave Pesicka moved to approve the February minutes as presented, seconded by Comm. Bill Henderson, all voted aye, motion carried.

NEW BUSINESS: The School Land Lease Auction will be held April 7th @ 10:00 a.m. in the Ziebach County Commissioner's room.

BRIDGE INSPECTIONS: Comm. S. Farlee moved to adopt the following resolution, seconded by Comm. Henderson, all voted aye, motion carried:

BRIDGE REINSPECTION PROGRAM RESOLUTION FOR USE WITH SDDOT RETAINER CONTRACTS

WHEREAS, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Ziebach County is desirous of participating in the Bridge Inspection Program.

The County requests SDDOT to hire Brosz Engineering Inc. (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection

services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

HWY. DEPT. REPORT: Jeff Jensen, Highway Superintendent presented his written report to the board. They are getting ready to start hauling gravel again as the weather begins to warm up. They haven't received any new applications for part time truck drivers or full-time equipment operators. Young Guns Construction will be putting in the bridge north of Dupree. They will have to move some fiber optic line. The county is willing to work with them and allow them set supplies and equipment in the yard at the shop as they begin construction. More updates on progress will come as they begin work. AES2, which is an engineering company out of Bismarck, contacted the county about acquiring easements for an approach that will connect to one of the county roads in Eagle Butte. They are working on the airport

project in Eagle Butte. The board will be able to make a decision, once more information is obtained.

More discussion was had on what to do with the road near the dump ground in Eagle Butte. The board has been in contact with Dakota Longbrake about the possibility of trading roads. No decisions will be made until further information is provided.

ADAM KOHLER ROAD WORK: Adam Kohler contacted the county about getting a road built near the old Raymond Ross place, as they are working on putting a house there. It would be extending the road that already exists about half a mile. County Policy is that the house has to be in place first, before the county will put in a road. The board agreed to build up the road and gravel it once the house is in place.

VEIT STOCKPILE ADDENDUM: Comm. Tucker Stocklin moved to approve the Veit Stockpile Addendum, seconded by Comm. Bill Henderson, all voted aye, motion carried. This will allow the county more time to haul and disperse the gravel stockpile at the Veit site for an additional two years.

FUEL QUOTES: The Highway Department called for quotes for P40 dyed diesel on February 27, 2025. The following quotes were received: Agtegra – P40 Dyed DSL, \$2.79; Farmers Union Oil – P40 Dyed DSL, \$2.875. The quote from Agtegra was accepted.

GAS QUOTES: The following quotes for gas were received: Agtegra—SNL Gas, \$2.819; Farmer's Union Oil – SNL Gas, \$2.709. Comm. Stocklin moved to accept the quote from FUOC, seconded by Comm. S. Farlee, all voted aye, motion carried.

2024 ANNUAL REPORT REVIEW: The Auditor reviewed the 2024 Annual Report with the Board. The report will be filed with Legislative Audit and published.

SHERIFF'S REPORTS: Gary Cudmore, Sheriff presented the monthly vehicle reports to the Board. Both the deputy and the sheriff have been sick throughout the month of February, which has kept them a little closer to town this past month. There was an incident on the bridge by Chris Johnson's. They discussed to possibility of putting a railing back up on the bridge. There has been a railing there before,

but it's been torn off because people can't get through with equipment. It was decided to leave the bridge as is.

EB UPPER ELEMENTARY RSO OFFICER: The Eagle Butte Upper Elementary is wanting to hire a school resource officer to ensure the safety of their students. Gary was able to put together some numbers as to what it would cost. The school would pay for the officer nine months out of the year and whichever entity provides the officer would pay the other three months. They are discussing whether the officer would be hired through the tribe or through the county. There is a possibility the county would pick up the officer. There will be more information on this in the coming months.

SURPLUS AUCTION SALE: At 2:00 PM, the Board auctioned the surplus property as listed and advertised.

LOSS CONTROL SURVEY RECOMMENDATIONS: The Board reviewed the Recommendations for Improvement made by our insurance carrier, SDPAA Insurance. The recommendations included safety plans and adding more policies to the Policy manual. Ziebach County will work to correct the items listed.

BUDGET SUPPLEMENT: Comm. S. Farlee moved to acknowledge receipt of \$2,000 from the office of the Attorney General and to supplement the budget using these funds along with the opioid money that the county has received as follows, seconded by Comm. Stocklin, all voted aye, motion carried:

OPERATING CASH TRANSFER: Comm. S. Farlee moved to transfer \$19,380.00 from the General Fund to the Emergency Management Fund as budgeted, seconded by Comm. Pesicka, all voted aye, motion carried.

2025 NEW OFFICIALS WORKSHOP: The 2025 New Officials Workshop will be held in Pierre, on April 9th & 10th. Permission for the auditor and treasurer to attend was granted.

EXECUTIVE SESSION: Dave Pesicka moved to go into executive session at 1:49 PM to discuss personnel, seconded by Comm. S. Farlee, all voted aye, motion carried. Olivia Dosch, Gary Cudmore and Shane Penefield were also present. The Board came out of executive session at 1:57 PM.
