

ZIEBACH COUNTY COMMISSIONERS

DECEMBER 29, 2025

The Ziebach County Commissioners met in special session at 1:00 PM with Shane Farlee, David Pesicka, Rick Farlee, Tucker Stocklin present. Chairman R. Farlee called the meeting to order.

MINUTES: Comm. Stocklin moved to approve the minutes as presented, seconded by Comm. S. Farlee, all voted aye, motion carried.

OLD BUSINESS: Commissioners have decided to make a committee up for putting together a bid packet for the road blading bid. Once they have discussed all details they will advertise in the paper.

GRAVEL HAULING BIDS: Williams Trucking LLC, was the only bid the commissioners received. Comm. Pesicka moved to accept Williams Trucking gravel hauling bid, Comm. S. Farlee seconded the motion, all vote aye, motion carried.

PRAIRIE DOG COMPLAINT: Commissioners' requested an update from State's Attorney Penfield on any communication on the progress of getting the situation resolved. State's Attorney Penfield informed the commissioners that they had until December 31st, 2025 to respond. Commissioner's requested for Penfield to make contact and request them to come to the next meeting, on January 6th, 2025.

4-H- CORINNA THOMPSON: Mrs. Thompson asked for permission to get trained on giving the Private Pesticide Applicators test. Comm. Stocklin made a motion to approve for Mrs. Thompson to become trained and to be able to administrate Private Pesticide Applicators test, Comm. S. Farlee seconded the motion, all vote aye, motion carried.

DEPARTMENT OF LABOR – ART CLIFTON: Commissioners have requested State's Attorney Penfield look into why we are still having to pay for Unemployment for an employee who quit in January of 2024. State's Attorney Penfield informed the commissioners' it is the state's law and that we need to look into getting Unemployment Insurance.

CONTINGENCY TRANSFERS: Comm. David Pesicka moved to transfer money from the Contingency Budget to the following budgets: \$500 to the Veteran Affairs, \$500 to the Domestic Abuse, seconded by Comm. S. Farlee, all voted aye, motion carried.

HIGHWAY SUPT. DEPT. REPORT: Jeff Jensen, Highway Superintendent, was not present but did have a roads report for Commissioner's to look at.
