The Greater Kansas City Pipe Club is a social club for pipe, tobacco, and cigar enthusiasts that cares about your privacy. We collect and use personal information only as needed to deliver our products and services, and to communicate with you about activities. Your personal information includes information such as:

- Name
- Address
- Telephone number
- Date of birth
- Email address
- Billing and payment information
- Other data collected that may identify you directly or indirectly

Our Privacy Policy not only explains how and why we use your personal information that we collect, but also how you can access, update, or otherwise take control of your personal information.

Information We Collect, How We Collect it, and Why

Your personal information may be collected directly when you:

- i. create an account or purchase any of our Services (ex: billing information, including name, address, credit card number, government identification);
- ii. request assistance from our customer support team (ex: phone number, voice recordings);
- iii. complete contact forms or request newsletters or other information from us (ex: email); or

Additional information may be collected when delivering our services to you to ensure necessary and optimal performance.

COOKIES

On our website can anonymously track browsing behavior, such as items purchased for inventory tracking. Specifically, the data collected relates to your interactions with our site features or third-party features, such as social media plugins, contained within the services; Internet Protocol (IP) address (for example, to determine your language preference; browser type and settings; the date and time the Services were used; device type and settings; operating system used; application IDs, unique device identifiers; and error data). Go Daddy technologies automatically collect data to measure website performance and improve our systems, including metadata, log

files, page load time, server response time to optimize DNS resolution, network routing and server configurations.

SUPPLEMENTED DATA

We may receive supplemental information about you from other sources, such as, from publicly available databases, social media platforms, or third parties. If you provide personal information about others, or if others give us your information, we will only use that information for the specific reason for which it was provided to us.

HOW WE UTILIZE INFORMATION

We minimize the data we collect and limit its use and purpose to only that (1) for which we have been given permission, (2) as necessary to deliver the services you purchase or interact with, or (3) as we might be required or permitted for legal compliance or other lawful purposes:

DELIVERY, IMPROVEMENT, UPDATING, AND ENHANCEMENT OF OUR SERVICES

We collect various information relating to your purchase, use and/or interactions with our services. We utilize this information to:

- Improve and optimize the operation and performance of our Services (again, including our websites and mobile applications)
- Diagnose problems with and identify any security and compliance risks, errors, or needed enhancements to the Services
- Detect and prevent fraud and abuse of our Services and systems

Much of the data collected is aggregated or statistical data about how individuals use our services and is not linked to any personal information.

SHARING WITH TRUSTED THIRD PARTIES

We may share your personal information with third parties with which we have partnered to allow you to integrate their services into our own services, and with trusted third-party service providers as necessary for them to perform services on our behalf, such as:

- Processing credit card payments
- Performing analysis of our services, customer demographics, and sentiment
- Communicating with you, such as by way of email or survey delivery
- Customer relationship management
- Security, risk management and compliance

These third parties (and any subcontractors they may be permitted to use) have agreed not to share, use, or retain your personal information for any purpose other than as necessary for the provision of services.

ADVERTISEMENTS

We do not use personal information to serve you ads.

COMMUNICATIONS WITH YOU

We may contact you directly or through a third-party service provider regarding products or services you have signed up or purchased from us, such as necessary to deliver transactional or service-related communications. We may also contact you with offers for additional services we think you'll find valuable if you give us consent, or where allowed to contact you based on legitimate interests. You don't need to provide consent as a condition to purchase our goods or services. These contacts may include:

- Email
- Text (SMS) messages
- Telephone calls
- Automated phone calls or text messages.

TRANSFERENCE OF PERSONAL INFORMATION ABROAD

LEGAL, REGULATORY, AND LAW ENFORCEMENT COMPLIANCE

To the extent we are legally permitted to do so, we may take reasonable steps to notify you if we are required to provide your personal information to third parties as part of legal process.

DATA SECURITY AND STORAGE

We follow generally accepted standards to store and protect the personal information we collect, both during transmission and once received and stored, including utilization of encryption where

appropriate. We retain personal information for as long as required to engage in the uses described in this Privacy Policy unless a longer retention period is required by applicable law.

The criteria used to determine our retention periods include the following:

- The length of time we have an ongoing relationship with you and provide services to you (for example, for as long as you have an account with us or keep using our Services);
- Whether account owners modify, or their users delete information through their accounts;
- Whether we have a legal obligation to keep the data (for example, certain laws require us to maintain records of your transactions for a certain timeframe before we can delete them); or
- Whether retention is advisable considering our legal position (such as, regarding the enforcement of our agreements, the resolution of disputes, and applicable statutes of limitations, litigation, or regulatory investigation).
