Re: *Centro Group LLC Investigation*

Dear Mr. Martin:

ACM Capital Partners, LLC engaged DiCicco, Gulman & Company LLP (“DGC”) on behalf of Centro Group, LLC to prepare a report of findings for work previously prepared by DGC at the direction of McLane Middleton. DGC was previously asked to investigate allegations of asset misappropriation by one of the principals of Centro Group, as well as, analyze the magnitude of a specific tax liability.

Qualifications

I am a partner and forensic accountant with DiCicco, Gulman & Company, LLC, located at 155 Federal Street, Boston MA, 02110. I am a Certified Public Accountant and licensed in the Commonwealth of Massachusetts and Accredited in Business Valuation by the American Institute of Certified Public Accountants. I hold an undergraduate degree in Business from Babson College and a Master of Science in Finance degree from Boston College. I have more than twenty years of experience, including matters involving complex accounting, fraud and forensic investigation, business valuations, business interruption, breach of contract, economic damages, and lost profits. My curriculum vitae is attached hereto as Exhibit 1.

Background

On or around April 25, 2018, Centro HCM, LLC merged with Centro Group, LLC. Centro Group, LLC (“Centro”) became the operating entity and a wholly-owned subsidiary of ProHCM Holdings, Inc. Centro is headquartered in Miami, Florida, but has offices in Boston, Massachusetts and St. Louis, Missouri. Centro combines technology platforms with centralized human capital management services through human resources and benefits consulting partners. Centro has a presence in 150 markets within the domestic United States. Centro is at times referred to as Simple Pay LLC.

On September 6, 2018, DGC was retained by McLane Middleton. The retention stemmed from a whistleblower claim raised by Iqra Sajid, Centro's Director of Finance, to Mino Capossela, an investor and board member of Centro. Ms. Sajid claimed that Mr. Capossela received a balance sheet from Chris Green, Centro's Chief Executive Officer, that was inaccurate and did not mirror the financial information that she provided to Mr. Green. Ms. Sajid communicated that other non-business payments were made with company funds.

Work Performed and Findings

DGC was retained as of September 6, 2018, however began its work on September 11, 2018. The work continued until DGC was instructed to stop its analysis on October 1, 2018. This report describes the work conducted during this period. The documents gathered during DGC's investigation and have utilized in relied upon in formulating my findings are referenced in this report.

Bank Statement Analysis – Bank of America (“BOA”)

On September 12, 2018, DGC was granted read-only access to Centro's accounts with Bank of America. These are the current bank accounts held by Centro.¹ DGC downloaded the statements for eight bank accounts held at this financial institution. The accounts are as follows, along with the period for which statements were available:

1. Account ending in 0753 (“BOA Account 0753”) – Taxes Kronos (April 2018 through August 2018);
2. Account ending in 0782 (“BOA Account 0782”) – Live Payroll Checks Kronos (April 2018 through August 2018);
3. Account ending in 0795 (“BOA Account 0795”) – Third Party Kronos (April 2018 through August 2018);
4. Account ending in 1098 (“BOA Account 1098”) – OBC (December 2016 through August 2018);
5. Account ending in 1108 (“BOA Account 1108”) – Taxes (December 2016 through August 2018);

¹ Centro held accounts at Capital Bank and Bank United prior to its relationship with Bank of America. DGC was provided copies of bank statements for accounts held by Centro at these financial institutions. Select records were made available for accounts held at Capital Bank in 2015. Select records were made available for accounts held at Bank United in 2015 and 2016. The records for accounts held at both financial institutions do not appear to be complete. However, it is believed that these accounts have been closed. The bank statements for Capital Bank and Bank United have not been analyzed to identify transactions that are inconsistent with the business' operations.

6. Account ending in 1111 (“BOA Account 1111”) – Client Other (December 2016 through August 2018);
7. Account ending in 1218 (“BOA Account 1218”) – Operating Account (November 2016 through August 2018); and
8. Account ending in 1221 (“BOA Account 1221”) – Estefan Accounts (November 2016 through August 2018).

DGC reviewed the transactions from the BOA Account bank statements. DGC found that multiple transactions were processed, which were inconsistent with the operational nature of the business. Specifically, transactions were directed to Mr. Green or on his behalf. The transactions identified to date are as follows:

1. On February 7, 2017, \$25,000.00 was wired to Mr. Green from BOA Account 1218. Refer to Exhibit 2.1.
2. On February 15, 2018, \$10,000.00 was transferred to Mr. Green from BOA Account 1218. Refer to Exhibit 2.2.
3. On February 27, 2018, \$16,719.99 was paid to the Carrollton School on behalf of Mr. Green from BOA Account 1218. It is understood that a child of Mr. Green attends this school. Refer to Exhibit 2.2.
4. On June 22, 2018, \$20,000.00 was transferred to Mr. Green from BOA Account 1221. Refer to Exhibit 2.3.
5. On July 12, 2018, \$10,000.00 was wired to Mr. Green from BOA Account 1221. Refer to Exhibit 2.4.
6. On August 21, 2018, \$50,000.00 was wired to Mr. Green from BOA Account 0753. Refer to Exhibit 2.5.
7. On August 21, 2018, \$50,000.00 was wired to Mr. Green from BOA Account 1108. Refer to Exhibit 2.6.

The transactions outlined above amount to \$181,719.99. The transactions are listed in Exhibit 3. This exhibit also shows the accounting entries recorded for each of these transactions, to the extent they were recorded in the company’s books and records. To the extent that a transaction was recorded in the company’s books and records, they were recognized for a purpose different than their actual purpose. The accounting entries are provided in Exhibit 3 as well. Ms. Sajid stated that she was instructed by Juan Martinez, Centro’s former Chief Financial Officer, to record transactions in a particular way. For example, the payment to the Carrollton School was recognized as a marketing expense.

In addition to the aforementioned transactions, on May 31, 2017, a \$78,602.80 a U.S. federal tax payment was made from BOA Account 1108. Refer to Exhibit 4. The description contains Mr. Green's name. It is unclear if this payment was made on his behalf or if he was processing a payment on another entity's behalf. Mr. Green also received \$10,988.32² in expense reimbursements which should be examined to determine whether they are for a business purpose. Refer to Exhibits 5.1 and 5.2.

There were other transactions that do not specifically identify Mr. Green, which were also inconsistent with the business' operations. For example, the bank statements for BOA Account 1218 also show payments totaling \$2,139.80 to Nordstrom.³ Refer to Exhibits 5.2 and 5.3. One of the Nordstrom payments was expensed to donations. In another example, Laura Angela Martinez, who is believed to be Mr. Martinez' wife, received three payments of \$11,820.00⁴ and one payment of \$11,820.03⁵ (or \$47,280.03 total) from BOA Account 1221. Refer to Exhibits 6.1 and 6.2. These payments may be related to a severance agreement between Centro and Mr. Martinez.

The examination and determination of the validity of expenses is incomplete and should continue.

Balance Sheet

DGC obtained a copy of Centro's QuickBooks file, which contains the company's general ledger, in order to analyze the company's financial position. Ms. Sajid stated that when she joined Centro in May 2017, the company did not have a general ledger system in use.

Therefore, Ms. Sajid implemented the use of QuickBooks to prepare income statements and balance sheets for the business. Ms. Sajid stated that she was provided with a beginning balance sheet as of December 31, 2016. She used the beginning balance sheet and the subsequent activity recorded in QuickBooks to roll the balances forward from that date.

The balance sheet, prepared by Ms. Sajid, reflected that Centro's liabilities exceeded its assets from December 31, 2016 and each month thereafter. The table below shows a summary of the balance sheet as of selected dates. A detailed monthly balance sheet can be found at Exhibit 7, including a listing of all accounts.

² Mr. Green received \$5,913.58 from BOA Account 1218 on May 26, 2017. Mr. Green also received 5,074.74 from BOA Account 1218 on July 3, 2017.

³ Payments were made from BOA Account 1218 to Nordstrom in the amounts of \$1,465.90 and \$673.90 on July 3, 2017 and March 2, 2018, respectively.

⁴ On July 2, 2018, July 13, 2018 and July 30, 2018, \$11,820.00 was wired to Laura Angela Martinez from BOA Account 1221.

⁵ On June 14, 2018, \$11,820.03 was wired to Laura Angela Martinez from BOA Account 1221.

Cash comprises the primary balance of the assets. Whereas, the clients' taxes payable accounts comprise the majority of the liabilities. Because the clients' taxes payable accounts hold client funds in escrow, these amounts do not belong to Centro. In fact, for every dollar of client taxes payable funds received, there should be a liability recorded on the balance sheet in the same amount. By way of example, if client ABC remits to Centro \$100 of funds to be held in escrow until the tax payment is due to the federal government, then Centro's balance sheet should also report a liability of \$100 reflecting that those funds are due to the federal government. The net effect of these accounting entries is zero because the asset and liability balances should be equal and offsetting.

Centro' balance sheet, however, did not present this picture and the Chief Financial Officer was aware of this imbalance between the relevant asset and liability accounts. On April 19, 2018, Mr. Martinez wrote an email to himself about the shortage of cash and the "hole." Refer to Exhibit 8. The "hole" is the excess amount of the clients' tax liabilities over the cash balances available to fund payment of that liability. Mr. Martinez described the "hole" as existing since he joined Centro. He stated that Mr. Green was aware of this situation no later than the early summer of 2017. Mr. Martinez' best estimate of the "hole" was \$800,000 to \$900,000, however according to Mr. Martinez, the "hole" had grown due to penalties and interest. It is not clear from Mr. Martinez' email, what was the date of his analysis that resulted in an estimated "hole" of \$800,000 to \$900,000.

Mr. Martinez also stated that there were transfers from escrowed funds to Centro's operating accounts. He specifically identified two transactions. The first transaction occurred on March 14, 2018 and was a transfer of \$47,620.08 from BOA Account 1221 (an escrow account) to BOA Account 1218 (an operating account). The second transaction occurred on April 4, 2018 and was a transfer to \$56,998.75 from BOA Account 1221 (an escrow account) to BOA Account 1218 (an operating account). It should be noted, however, that there are other transfers between BOA Account 1221 and BOA Account 1218 that were not addressed in this email.⁶ In addition, there are other transfers between other BOA Accounts that also will require examination.

⁶ By way of example, \$73,211.95 was deposited into BOA Account 1218 from BOA Account 1221. Refer to Exhibit 9.

Mr. Martinez' email, along with the accurate financial statements, however, were not provided to investors prior to the ProHCM merger with Centro. Mr. Capossela provided DGC a copy of a December 31, 2017 dated balance sheet. This balance sheet reported total assets of \$573,333.57 and liabilities of \$388,962.61. Furthermore, the checking and savings accounts were valued at \$411,260.76 with client liabilities of \$383,181.45. The table below shows a summary comparison of what was received by Mr. Capossela and Centro's internal reporting as of the same date.

Based on this comparison, the reader of the financial statement received by Mr. Capossela would be led to believe that the cash on hand as of December 31, 2017 exceeded the monies held in escrow on behalf of clients. On the other hand, the reader of the Centro internal balance sheet would understand that the liabilities exceed the cash on hand as of the same date.

Accounting Processes and Procedures

DGC interviewed Ms. Sajid on multiple occasions in September 2018 to understand the accounting processes and procedures that were employed at Centro. DGC determined that there were no standard operating procedures employed on a consistent basis with respect to financial management and reporting. The bank accounts were not reconciled on a consistent basis. More specifically, the client funds received and remitted were not reconciled with the accounting entries recorded in QuickBooks or the tax liabilities reported in the MasterTax⁷ software used by Centro.

⁷ MasterTax is a payroll tax software, which works with payroll systems and enables the scheduling, payment and filing of payroll taxes. Centro began using MasterTax in 2016, however full adoption of its use was not until early 2017. Ms. Sajid was not aware of the software used prior to MasterTax.

Ms. Sajid⁸ and Terry Pino⁹, another Centro accounting staff, attempted to establish certain standard procedures to manage the volume of transactions. For example, prior to Ms. Sajid's employment, many of the individual client liabilities were paid in batches from bank accounts. This meant that, by way of example, ten clients' tax payable would be reflected by one cash payment from the bank account to the Federal government. Because a reconciliation process was not employed, it was difficult to confirm that individual client liabilities were paid and extinguished. Ms. Sajid changed the process, so that each liability was individually paid from the bank accounts. This process appears to have been implemented on or around June 15, 2017. However, the bank accounts continued to not be reconciled.

In another example, it was learned by both Ms. Sajid and Ms. Pino upon their joining Centro, that there was no repository for tax notices. Tax notices are not reflected in the MasterTax software. Centro received tax notices from Federal, state and local agencies. The notices stemmed from the late payment of client tax liabilities. The notices claimed monetary amounts for penalties and interest on the late payments. Ms. Pino focused on resolution of the notices with multiple state agencies. In order to establish a process, to the extent notices were presented to her, she compiled monthly worksheets to log and quantify the penalties and interest by client. She also contacted the state agencies to triage and resolve outstanding balances. This process, however, was ceased upon her leaving Centro in June of this year.

Because of Centro's cash constraints, Ms. Sajid managed the payments of tax liabilities by comparing the amount due against the cash on hand balances. Ms. Sajid stated that she would download a report from MasterTax each day to ascertain the taxes payable amounts due to Federal, state and local agencies. This report, however, did not reflect penalties and interest that had accrued on late payments. Ms. Sajid stated that as a result of the liabilities exceeding the cash on hand, many clients' taxes payable were paid late. In particular, many Federal liabilities were paid late.

Client Taxes Payable Balances

DGC was provided a download of the tax liabilities as of September 26, 2018. Refer to Exhibit 10. The MasterTax report showed \$1,732,575.53 of liabilities that were due and payable, but had not been extinguished. The tax liabilities show due dates of September 6, 2018 through September 28, 2018. Therefore, some of the liabilities were twenty days overdue as of the date of this report. Whereas, other liabilities were coming due within the following two days. However, due to the lack of reconciliation processed employed by the company, DGC undertook a reconciliation process for these liabilities.

⁸ Iqra Sajid, Centro's Director of finance, began working at Centro in May 2017. She remained employed by Centro as of the date of our interview with her on September 28, 2018.

⁹ Terry Pino began working at Centro in June 2017. She remained employed at Centro until June 2018.

DGC learned, through interviews with Ms. Sajid, that the late payments of tax liabilities were limited to iSolved clients. The iSolved clients' payments and remittances were made within BOA Account 1108. Because of the batch processing of payment of tax liabilities before June 15, 2017, the reconciliation process was initiated as of this date.

All MasterTax transactions were downloaded from May 2, 2016¹⁰ through September 21, 2018. The iSolved clients were identified through a filtering process of the MasterTax data. This filtering process included the following:

- Removing Kronos clients from the data set;
- Excluding transactions from June 15, 2017 and before; and
- Resolving discrepancies in liability amounts between MasterTax and underlying accounting records.

From this reconciliation process, DGC confirmed the outstanding iSolved liability balance of \$1,732,575.53 as of September 26, 2018. This balance does not include penalties and interest levied against previously paid tax liabilities, nor does it include penalties and interest which will be levied for the late payment of these liabilities. The magnitude of the penalty and interest amounts are unknown at this time. The outstanding liability also does not include quarterly payments, which had been accrued and were due on September 30, 2018. The magnitude of this liability is unknown at this time. Finally, DGC identified approximately \$110,538.95 of potential liabilities that may not have been extinguished. These items require further investigation. Exhibit 11 to this report shows this amount.

The iSolved liability has changed over time due to multiple factors. DGC was told, but to date has not seen evidence, of a capital raise that may have impacted the liability's balance. In addition, the liability has exceeded the cash on hand available to resolve these clients' tax liabilities. According to the balance sheet prepared by Ms. Sajid, this issue has existed since, at least, December 31, 2016. Therefore, the books and records of the company should be reconstructed for calendar years 2015 and 2016 to understand the starting point of the problem with respect to the iSolved liability. Furthermore, the other escrow accounts should be reconciled to determine the source and disposition of those funds for the same time period.

How to Contact Us - You may call us at the telephone number listed on the front of this statement.

Updating your contact information - We encourage you to keep your contact information up-to-date. This includes address, email and phone number. If your information has changed, the easiest way to update it is by visiting the Help & Support tab of Online Banking.

Deposit agreement - When you opened your account, you received a deposit agreement and fee schedule and agreed that your account would be governed by the terms of these documents, as we may amend them from time to time. These documents are part of the contract for your deposit account and govern all transactions relating to your account, including all deposits and withdrawals. Copies of both the deposit agreement and fee schedule which contain the current version of the terms and conditions of your account relationship may be obtained at our financial centers.

Electronic transfers: In case of errors or questions about your electronic transfers - If you think your statement or receipt is wrong or you need more information about an electronic transfer (e.g., ATM transactions, direct deposits or withdrawals, point-of-sale transactions) on the statement or receipt, telephone or write us at the address and number listed on the front of this statement as soon as you can. We must hear from you no later than 60 days after we sent you the FIRST statement on which the error or problem appeared.

- Tell us your name and account number.
- Describe the error or transfer you are unsure about, and explain as clearly as you can why you believe there is an error or why you need more information.
- Tell us the dollar amount of the suspected error.

For consumer accounts used primarily for personal, family or household purposes, we will investigate your complaint and will correct any error promptly. If we take more than 10 business days (10 calendar days if you are a Massachusetts customer) (20 business days if you are a new customer, for electronic transfers occurring during the first 30 days after the first deposit is made to your account) to do this, we will provisionally credit your account for the amount you think is in error, so that you will have use of the money during the time it will take to complete our investigation.

For other accounts, we investigate, and if we find we have made an error, we credit your account at the conclusion of our investigation.

Reporting other problems - You must examine your statement carefully and promptly. You are in the best position to discover errors and unauthorized transactions on your account. If you fail to notify us in writing of suspected problems or an unauthorized transaction within the time period specified in the deposit agreement (which periods are no more than 60 days after we make the statement available to you and in some cases are 30 days or less), we are not liable to you and you agree to not make a claim against us, for the problems or unauthorized transactions.

Direct deposits - If you have arranged to have direct deposits made to your account at least once every 60 days from the same person or company, you may call us to find out if the deposit was made as scheduled. You may also review your activity online or visit a financial center for information.

I have had several conversations over the last year with Chris regarding the significant shortfall in cash available for client tax payments.

The “hole” as we refer to the shortage has existed since well before I arrived and was brought to the attention of Chris Green, Jay Leyva, and Abdel Karim no later than the early summer of 2017. The amount as best I was able to calculate was approximately \$800K to 900K. It has since grown with the additions of more penalties and interest. This has caused us to be late in our client payments.

I am documenting this to protect myself. I was asked to move client impounded cash in March and April of 2018 to the CENTRO (Simplepay) operating account. Total of transfers was \$104,618.83 over two transfers made on 3/14/2018 for \$47,620.08 and 4/4 for \$56998.75. In both cases I was assured that the merger was close and that the cash would be made available to replace the money.

This past Monday Chris and I had a very heated discussion about the shortfall and what is being done about it. I explained the various terrible outcomes if we do not very quickly take this issue seriously and correct it. Everything from this being a criminal act to the scandal that will befall shareholders.

I have confirmed with Chris now several times that the only people that know about the “hole” are Chris, Jay, Abdel, myself, Iqra, Terry and I am sure Keila [note: Chris Green, Jay Leyva (Simple Pay Founder and then Centro LLC shareholder), Terry was a Centro employee who did taxes, and Keila still works at Centro doing payroll]]. No one outside of these people are aware of the situation...No board members, no ProHCM people.

Chris has suggested that we address the issue when he arrives from Boston next week. Yesterday 4/18 he came to my office while I was alone and explained that we were getting \$30K from PRO to be able to cover payroll for CENTRO. He added that one of the new investors (the new chairman) was going to lend us some cash that we will finally use to replace the money taken from client impounded cash. He believes the timing on this is this week as closing occurs before Friday. (it was supposed to have been on 4/15).

I have asked Chris that he explain to me how he intends to “repay” the hole. He explained that we will pay once the merger is closed and we can access larger cash resources. When I asked how this money being taken from profits, will be categorized or explained to his shareholders he said we will classify the amounts as payroll or other expenses and continue to disguise the payments. I took a breathe and immediately told him that I will not do that.

I explained that that is something he should not expect from me or anyone on my team.

At no time has Iqra or Terry been involved directly in any of these fraudulent transactions.
