# THUNDER READY BACKUP POWER & SAFE ROOMS STRUCTURAL FAILURE OF SAFE ROOM WARRANTY & DISCLAIMERS

This limited warranty is provided by De Vaughn, LLC d/b/a Thunder Ready Backup Power & Safe Rooms (Thunder Ready) an Oklahoma limited liability company, to Registered Consumer (Consumer).

This warranty applies only to Thunder Ready Back-up Power Systems and Safe Rooms installed in residential dwellings in the United States.

This warranty applies solely to original consumer, but original consumer may transfer registration of this warranty one time to an owner of the Host Dwelling (defined below) within the warranty period. All other transfers of this warranty are void.

## The warranty is limited to:

1. Structural failure due to corrosion of Thunder Ready Safe Room(s) within ten (10) years of installation date.
2. All other Thunder Ready Products not listed in item one (1) will have a one (1) year workmanship warranty from date of installation. The manufacturer's product warranty may extend beyond the Thunder Ready Warranty.

## Warranty

Subject to the conditions below, if any Thunder Ready Safe Room structurally fails due to corrosion, or any Thunder Ready Product fails due to workmanship within the applicable warranty period(s) listed above, Thunder Ready will either (a) repair or replace the affected Parts/Products, or (b) pay the cost of having the Parts or Products repaired or replaced. To the extent permitted by law, Thunder Ready's entire liability shall be limited to the foregoing and shall not be liable for any incidental, consequential, or punitive damages, including injury to persons arising from the use of the product.

## Conditions

Host Dwelling: The residential dwelling in which the Thunder Ready Product(s) is/are installed and reside.

The Thunder Ready Products must be installed within the recommended location of the Host Dwelling. Installing a Thunder Ready Product in a location NOT recommended could void the warranty in the event access for warranty service is impaired. When installing a Thunder Ready Product in a location NOT recommended, neither Thunder Ready nor it's representative shall be responsible for any damages that occur during repair or replacement.

The Thunder Ready Products must be installed in accordance with manufacturer's published installation procedures.

Thunder Ready Product must be easily accessible. The Thunder Ready representative performing warranty or non-warranty work is NOT responsible for removing or damaging finished items. Thunder Ready, nor it's representative, are responsible for any damage to any property while repairing or replacing the Thunder Ready Product(s).

Consumer must provide proof of purchase of Thunder Ready Products for warranty to be valid. If transferred, the new owner of the Host Dwelling must provide proof of transfer of warranty to Thunder Ready for warranty to be valid.

The owner of the Host Dwelling must grant Thunder Ready or its representative the right to access the installation site to inspect the installation process at any time a claim is made under this warranty.

Damage due to the improper usage by consumer or any other person or animal will NOT be covered by this warranty.

## CUSTOMER BULLETIN 20-08

**THE SAFE OPERATION AND USE OF THE THUNDER READY SAFE ROOM IS THE RESPONSIBILITY OF THE OWNER/ADULT OCCUPANT.** Thunder Ready Safe Rooms are not a play space for children. The shelter door weighs hundreds of pounds; children can be easily injured.

### SAFETY INFORMATION:

1. NEVER leave children unattended while the Thunder Ready Safe Room is open.
2. NEVER weld, drill, grind, or cut the Thunder Ready Safe Room.
3. ALWAYS keep hands clear of door frame and edges while door is in motion.
4. ALWAYS register your shelter with local emergency responders.

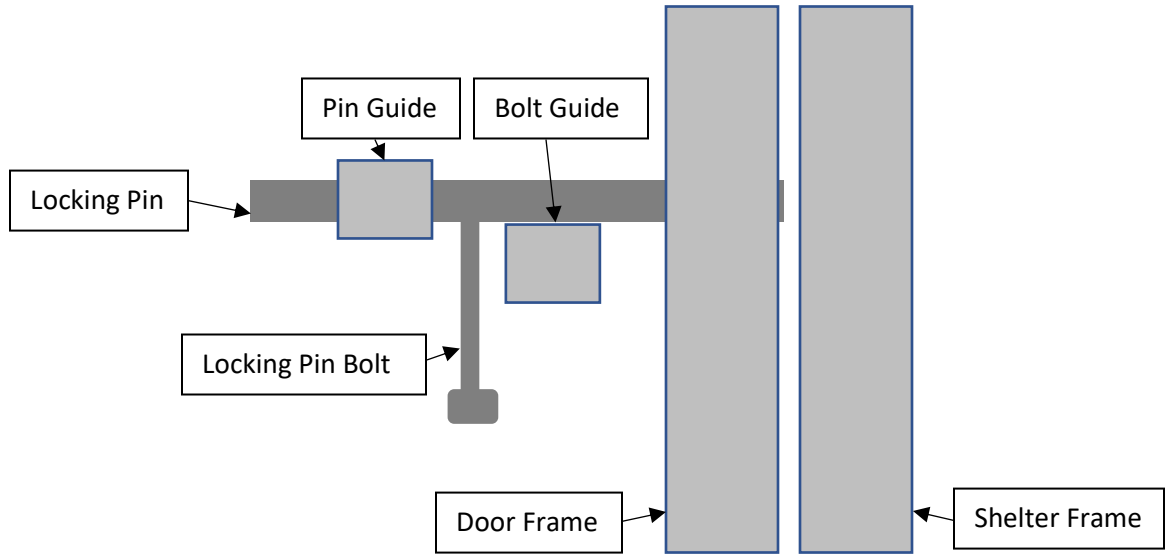
### Dead-bolt Lock and Locking Pins:

The Thunder Ready Safe Room has a keyed deadbolt for securing the door when not occupied. To properly secure the door while occupied, locking pins accessible from the shelter's interior are the primary means to secure the door. Use of the deadbolt is optional when safe room is occupied.

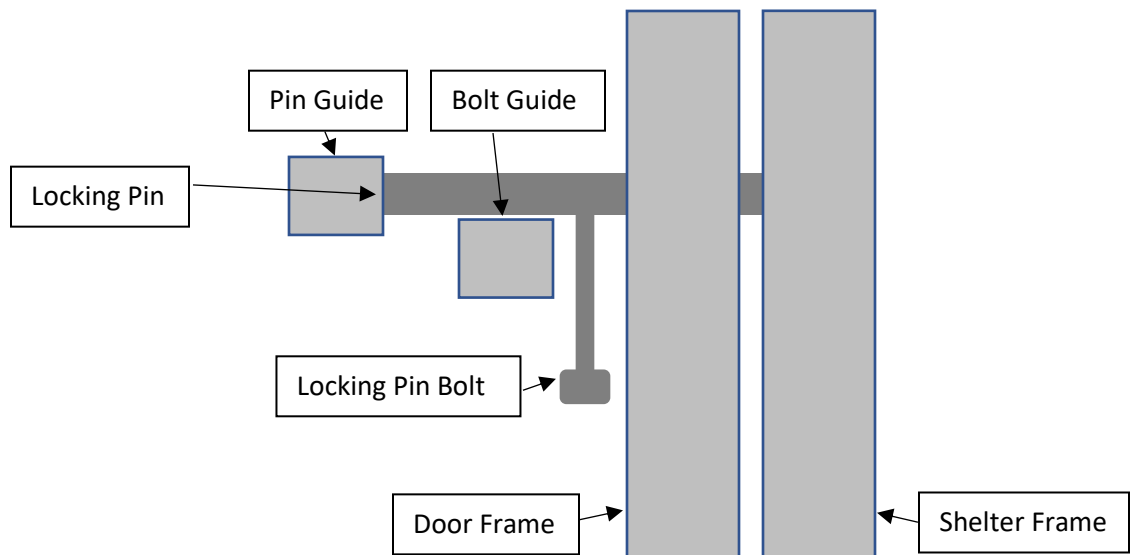
### Tornadic Events:

1. Ensure all Locking Pins are engaged; see Illustration 08-01 (next page).
2. Ensure all vents are clear and free of obstructions.
3. Occupants shall not touch, and remain 2 inches from, walls and door.
4. Occupants more than 5'10" in height shall kneel or be seated.
5. Occupants should cover ears or wear hearing protection.
