

## **Corridor Volleyball Club**

### **Registration Fee Reduction & Family Discount Policy**

**Effective Date: Jan 1<sup>st</sup> 2026**

#### **1. Purpose**

This policy exists to:

- Recognize the significant time, effort, and leadership contributed by coaches and board members, and
- Support families with multiple athletes registered in Corridor Volleyball Club, while maintaining fairness and budget clarity.

#### **2. Definition of Eligible Volunteer Roles**

For the purposes of registration fee reductions, **only the following roles are eligible:**

- Head Coach
- Assistant Coach
- Board Member

Other volunteer roles (e.g., team manager, ad-hoc event support, fundraising assistance) are appreciated but **are not eligible** for registration fee reductions under this policy.

#### **3. Coach & Board Member Registration Fee Reduction**

- A parent or guardian serving as a **Head Coach, Assistant Coach, or Board Member** is eligible for a **50% reduction of the athlete registration fee** for one child.
- The reduction applies **only to the standard \$400 registration fee** and does not apply to fundraising requirements.
- All families, including those receiving a registration reduction, are still expected to meet the full fundraising goal.

## Additional Contribution Recognition

- If a parent or guardian:
  - Coaches **two teams**, or
  - Coaches **one team and serves on the Board**,

the Club will recognize this additional contribution by applying the **50% registration fee reduction to two registered athletes**, provided the volunteer has two children registered with the Club.

- Coaching multiple teams or combining coaching and board service is recognized as a significant commitment requiring additional time, preparation, and leadership both on and off the court.

## 4. Multiple-Athlete Family Discount

- Families with **more than one child registered** with Corridor Volleyball Club during the same season are eligible for a \$50 reduction per athlete.
- This reduction may be applied in one of the following ways:
  - As a credit toward the athlete's registration fee, or
  - As a credit toward the family's fundraising requirement.
- Where possible, the \$50 reduction will be **applied upfront** to reduce the amount owed, rather than requiring families to pay the full amount and receive a reimbursement later.

## 5. Combination of Reductions

- Families may qualify for **both**:
  - A coach/board member registration reduction, and
  - A multiple-athlete family discount, provided all eligibility requirements are met.

- No reduction or credit may exceed the amount payable for registration fees or Fundraising obligations.

## **6. Administration & Approval**

- All reductions and credits are subject to verification and approval by the Corridor Volleyball Club Executive.
- The Club reserves the right to amend or discontinue this policy as operational or financial needs require, with notice provided to members.
