DBE CERTIFICATION APPLICATION SUPPORTING DOCUMENTS CHECKLIST

In order to complete your application for DBE certification, you must attach copies of all of the following documents as they apply to you and your firm.

ALL APPLICANTS MUST PROVIDE THE FOLLOWING ITEMS:

- Proof of U.S. Citizenship/Permanent Resident Status & Ethnicity (Birth Certificate, U.S. Passport,)
- Work experience resumes, for all owners and officers of your firm
- Personal Financial Statement (form available with this application) ***WE COMPLETE THIS**
- Personal tax returns for the past three years, for each owner ****SIGNED****
- Firm's tax returns (gross receipts) and all related schedules for the past three years ****SIGNED****
- Documented proof of contributions used to acquire ownership for each owner
- Firm's signed loan agreements, security agreements, and bonding forms
- Descriptions of all real estate (including office/storage space) owned/leased by your firm owners
- List of equipment leased and signed lease agreements. **Include **Vehicle Registrations****
- List of construction equipment and/or vehicles owned and titles/proof of ownership
- Assumed name certificate with stamp approval date
- Documented proof of any transfers of assets to/from your its owners over the past two year's
- Year-end balance sheets and income statements for the past three years
- All relevant licenses, license renewal forms, permits, and haul authority forms
- DBE and SBA 8(a) or SDB certifications, denials, and/or de-certifications, if applicable
- Bank authorization and signatory cards
- Schedule of salaries (or other compensation) paid to all officers, managers, owners, of the firm
- Trust agreements held by any owner claiming disadvantaged status, if any
- Driver's License (enlarged to 125%)
- Three (3) References (name, telephone, How much \$\$ in business with them)

PARTNERSHIP OR JOINT VENTURE

- Original and any amended Partnership or Joint Venture Agreements

CORPORATION OR LLC

- Official Articles of Incorporation - signed and sealed by a state official
- Stock transfer ledger and both sides-of all corporate stock certificates
- Shareholders' Agreement
- Minutes of all stockholders and board of directors meetings
- Corporate by-laws and any amendments
- Corporate bank resolution and bank signature card (s)
- LLC - Official Certificate of Formation and Operating Agreement with amendments

TRUCKING COMPANIES

- Documented proof of ownership of the company
- Insurance agreements for each truck owned or operated by your firm
- Title(s) and registration certificate(s) for each truck owned or operated by your firm
- List of U.S. DOT numbers for each truck owned or operated by your firm
