Peregrination Contractors was contracted to address an existing sewer lateral failure caused by the original contractor. Our scope of work included the removal of the failed system and installation of a new 4-inch sewer lateral, securely tied into an 8-inch PVC SDR 35 main using a saddle connection. The project required backfilling and compaction in both the roadway and green space, asphalt restoration in the roadway, and grading for concrete placement. The green areas were graded and prepared for sod installation. Upon completion, the roadway and all work areas were fully restored to their original condition. The new installation was then inspected via camera and successfully passed for active use
