

## **Dog Boarding Waiver & Liability Release** 🐾

This Waiver & Liability Release is required for all clients of Howliday Inn. Please read carefully, as it outlines the terms under which your dog will be cared for while boarding or attending daycare.

### **Owner's Responsibility**

- I certify that my dog is current on all required vaccinations (rabies, bordetella, DHPP).
- I certify that my dog is current on flea/tick preventative medications and is free of fleas, ticks, and contagious illnesses.
- I have disclosed any medical conditions, allergies, or behavioral issues to Howliday Inn.

### **Assumption of Risk**

- I understand that while every effort will be made to ensure the safety and well-being of my dog, dogs can sometimes become ill or injured during boarding or daycare.
- I accept all risks associated with boarding/daycare, including but not limited to: illness, injury, stress, or behavioral changes.

### **Medical Care Authorization**

- In the event of an emergency, I authorize Howliday Inn to seek veterinary care for my dog.
- I agree to be responsible for all veterinary costs incurred during my dog's stay.
- If my preferred veterinarian is unavailable, I authorize care to be sought from the on-call mobile veterinarian or the nearest emergency veterinary clinic.

### **Hurricane Release**

- This includes but is not limited to hurricanes, tropical storms, severe thunderstorms, and any other potentially violent or severe weather.
- I acknowledge and hereby agree not to hold Howliday Inn responsible for any damages or injuries to my dog(s) as a result of any severe weather activities sustained during the applicable boarding period.
- In the event of a hurricane threat, I reserve the right to pick up my pet regardless of the number of days remaining in the reservation. I will only be required to pay for the day(s) the dog(s) have been on the premises.

### **Medication Administration Waiver**

- All prescription medications must be given to Howliday Inn in the original bottle from your veterinarian with detailed instructions. All supplements must be in a pill organizer labeled with dog's name and accompanied by instructions for administering.
- I acknowledge and hereby agree not to hold Howliday Inn responsible for any adverse effects to your pet as a result of medication administered while in the care of Howliday Inn.

### **Liability Release**

- I release Howliday Inn, its owner(s), and staff from any liability for illness, injury, or loss that may occur during my dog's stay, except in cases of gross negligence or willful misconduct.
- I acknowledge that dogs interact with each other and with humans, and that risks cannot be completely eliminated.

### **Payment & Cancellations**

- I understand that payment is due at pick-up unless other arrangements are made.
- I understand that cancellations made less than seven (7) days in advance may be subject to fees.
