Update on Annual Meeting October 16 (by Ed Walsh)

Election Results: The following people were elected to the board

Financial Status: Diann Hallman presented the financial report.

-As a result of continued cost controls, coupled with minor maintenance costs this year, there will not be a dues increase for 2011. Also factored into the decision was the fact that times are very difficult for many people due to current economic conditions.

- Unfortunately we have had some foreclosures this year. We were lucky to be able to receive initiation fees and dues when they got sold.

- Our capital reserve fund continues to be funded each year. This fund was started a couple of years ago for the express purpose of saving for any major repairs to the lake or the gazebos.

- The current budget contains a number of items budgeted for various repairs during 2010 (gazebos, irrigation, painting fences, etc) Fortunately we have only experienced minor maintenance costs this year. As a result, the monies earmarked for those repairs will be rolled over into the capital reserve fund for future repairs to the lake and gazebos.

- It is the intent of the board to hold controllable expenses to current levels thru 2011.

Note – A special word of thanks to Diann for her work as our treasurer. I'm not sure many people realize how difficult and time consuming the treasurer's job is. Aside from keeping track of dues payments from 70 plus families, there is the fun job of trying to get everyone to pay their dues. There are the tax returns, paying all the bills, insuring compliance with state and IRS rules governing HOAs. Even more

difficult and time consuming is the budgeting process. At best it is a difficult process. Diann is one of the reasons that the Cruce Lake HOA continues to be in sound financial shape.

Activity Committee : Tiffany Moore heads up the activity committee

Talked about the need for some volunteers to help with activities as well as provide ideas for possible activities you'd like to see next year. Some ideas already presented are hiring a Santa at the Gazebo, card games, bowling, and a book club. If you would like to help or have some ideas please contact Tiffany.

Future Maintenance Issues: Ed Walsh

Talked about various future maintenance issues. The biggest issues we will face in the future is the repair of the lake's drainage pipes. They were repaired a few years ago by volunteer neighbors, but the repair was really of a temporary nature. The system continues to deteriorate due to age and we will have to replace the system in the future. We are hoping that the system holds out long enough for our capital reserve fund to build up enough to cover the cost of replacement. The next biggest maintenance issues are the gazebos. The gazebo on the water is of the biggest concern. The wood is deteriorating and one of the corners is beginning to sag. We don't know if it is the piling sinking/rusting or if the floor beams are sagging. This gazebo has taken a beating the past year or so with all the rain. There have been at least 6 times that the gazebo deck has been covered by water from rain storms. At some point in the next 3-5 years we will have to make a community decision on the best option for that gazebo (ie, repair, replace, eliminate, etc). The gazebo up by the parking lot will need to be painted in the next couple of years. I think we can get by with doing some touch up painting on the railings and posts. I would guess the cost to have it painted would be in the \$3k - \$4 range.


Last but not least a word of thanks to ... Bo the neighborhood wonderdog.
