We are very lucky to have these folks step up and devote their time and effort on behalf of the homeowners. We also would like to thank outgoing directors Brenda Peppers and Tiffany Moore for all their efforts on behalf of the homeowners over the past 2 years.

The following is a rundown of the meeting. Please do not hesitate to call on any board member if you have any questions or concerns.



Financial: Diann Hallman provided an overview of the current financial condition of the Cruce Lake HOA. In a nutshell, the HOA is in excellent financial condition and is continuing to make progress in setting aside funds for future anticipated repairs to both the lake drainage system and both gazebos. As a result of ongoing cost cutting activities and lower than anticipated maintenance expenses there will not be a dues increase for 2012. Please contact Diann Hallman if you would like a copy of the current balance sheet. We all owe a debt of gratitude to Diann for continuing to do such an excellent job on our finances. It is at best a difficult and time consuming effort.



Vandalism: We've experienced a few incidents of vandalism to the gazebos over the past few months. Reports have been made to the police and they have been providing additional patrols at night. In addition the board contracted with Jackson EMC to install 2 security lights illuminating both gazebos. While we would have preferred to have the wiring placed underground, the cost was prohibitive. We tried to have the poles placed in such a way as to be least intrusive. Hopefully the additional lighting will help deter vandals. The police have told us to not hesitate to call them if we see people hanging around there late at night. They assured us they will investigate and remove trespassers.



Gazebo Repairs: The board contracted to have both gazebos repaired and painted this summer. Although the gazebo by the parking lot is in relatively good shape, the one on the water is in a state of advanced deterioration. This gazebo does not have a covered roof on it and therefore is more susceptible to the sun's damage over the years. There appears to be some structural issues with the supports in the water. In addition there is substantial rot to a good portion of that part of the gazebo above the waterline. We have solicited volunteers from the community with the necessary expertise to get together and try and ascertain the extent of the damage and to make recommendations to the board of what can be done to preserve the gazebo. It is the intent of the board to provide all homeowners the opportunity to provide input on the various solutions that come as a result of these volunteers investigation. A decision was made this summer to make some necessary repairs to both gazebos in order to insure the safety of anyone using them. Both were painted in order to help protect them from additional wear and tear from the elements and give us a couple of more years before we have to do major repairs.



Santa: Please mark your calendars – Santa has agreed to visit our children once again this year. He will be at the gazebo on December 4th from 4:00 to 5:00p.m. Full details will be provided as we get closer to the date.



Activities Committee: We would like to do a better job this year and hold a number of community events for both children and adults. We received a number of suggestions from homeowners (Easter egg hunt, fishing tournament, ornament exchange, movies at the gazebo, ladies night out, to name a few). With that in mind we are looking for some additional volunteers to help in organizing these events. Beaver Problem: Once again the beavers have taken up residence in the lake and are beginning to cause some damage. This has been a fairly on-going issue but thanks to the efforts of Doug Erwin the beaver population has been kept in check by trapping and removing them. Left unchecked, the beavers will cause damage to the lake and homeowner's trees.



Architectural Control Committee (ACC): We are seeking volunteers to join the ACC board for 2012. The purpose of the board is to review and approve any external changes to homes submitted by homeowners to insure they are in sync with the existing covenants. In addition, the board is responsible for insuring that all homeowners adhere to the covenants thereby helping insure Cruce Lake remains a great place to live and helping insure home values are protected to the greatest extent possible. In these tough economic times it is even more important that each of us keep our homes maintained properly. All of us benefit from living in a well maintained neighborhood.
