What is a member in good standing?

The board has reviewed our existing guidelines for being a "member in good standings" and have decided that our original requirements were too stringent, making it almost impossible for any member to achieve.

Fortunately, knowing that our first attempt of rules for membership may changed as we progressed from our genesis to current state, our guidelines are constructed in such a manner that they can be change when the need requires them to be changed.

With that in mind, the board approved the following as our new requirements for being a member in good standings. I believe the collection of revamped requirements give each member more and different options to participate and grow in our association. Below are the new requirements:

- 1. Members must meet the following membership requirements.
 - a. To be an active member
 - i. Paying annual membership dues of \$25.00; and participate in one of the following activities.
 - 1. Participating in one (1) NBPBA burn projects of other members per fiscal year to include the actual burn, or burn site preparation or burn plan writing and site evaluation.
 - 2. Attend one (1) burn training per fiscal year endorsed by the Board of Directors; to include NBPBA hosted training or training provided by Missouri Department of Conservation or other accredited organizations.
 - 3. Administrative service to the NBPBA (Board of Directors, committee volunteer, etc.) may be given credit in lieu of one burn participation.
 - 4. Attend one of our semi-annual member meetings.
 - b. Before a burn can be conducted on your property or the property in which they are the Land Manager as designated by the Landowner you must:
 - i. Completed the MDC Landowner Burn Workshop or equivalent.

As you can see besides your annual dues of 25.00 dollars, you now have four different activities of participation to be in good standings.

Notice that you can participate in burns without being MDC certified; but to perform a burn on your property you must complete the MDC Landowners Burn Workshop or equivalent curriculum.
